2855 ASSIGNMENT OF MORTGAGE

Know All Men By These Presents, That the GREAT LAKES MORTGAGE CORPORATION a Corporation of the State of Illinois, the party of the first part, in consideration of the sum of TEN THOUSAND AND NO/100 Dollars (\$ 10,000.00), lawful money of the United States of America, to it in hand paid by FEDERAL NATIONAL MORTGAGE ASSOCIATION, a Corporation organized under an act of Congress and existing pursuant to the Federal National Mortgage Association charter act, the party of the second part, at or before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, transferred and set over, and by these Presents does grant, bargain, sell, assign, transfer and set over unto the said party of the second part, its successors and assigns, a certain Indenture of Mortgage, bearing date the 12th day of December, A. D. 19 68, made by Redford K. Bean and Mary F. Bean, his wife of the City of Hammond, of the County of Lake and State of Indiana, and all its right, title and interest to the premises therein described as follows, to-wit:
Lot 23, M. W. Sutton's 1st Addition to Hammond, as shown in Plat Book 23, page 33, in Lake County, Indiana.

which said Mortgage is recorded in the recorder's Office of the County of Lake in the State of Indiana, in at page as Document Number 301

Together with the principal note therein described, and the money due or to grow due thereon with the interest, To Have and To Hold the same unto the said party of the second part, its Successors or assigns, Forever, subject only to the provisos in the said Indenture of Mortgage contained:

The Party of the first part covenants that there is now due and owing upon said mortgage and note the principal sum of TEN THOUSAND AND NO/100 Dollars (\$ 10,000.00) with interest from January 22, 1969

And It does hereby make, constitute and appoint the said party of the second part its true and lawful Attorney, irrevocably, in its name, or otherwise, but at its own proper costs and charges, to have, use and take all lawful ways and means for the recovery of the said money and interest, and, in case of payment to discharge the same as fully as it might, or could do, if these Presents were not made.

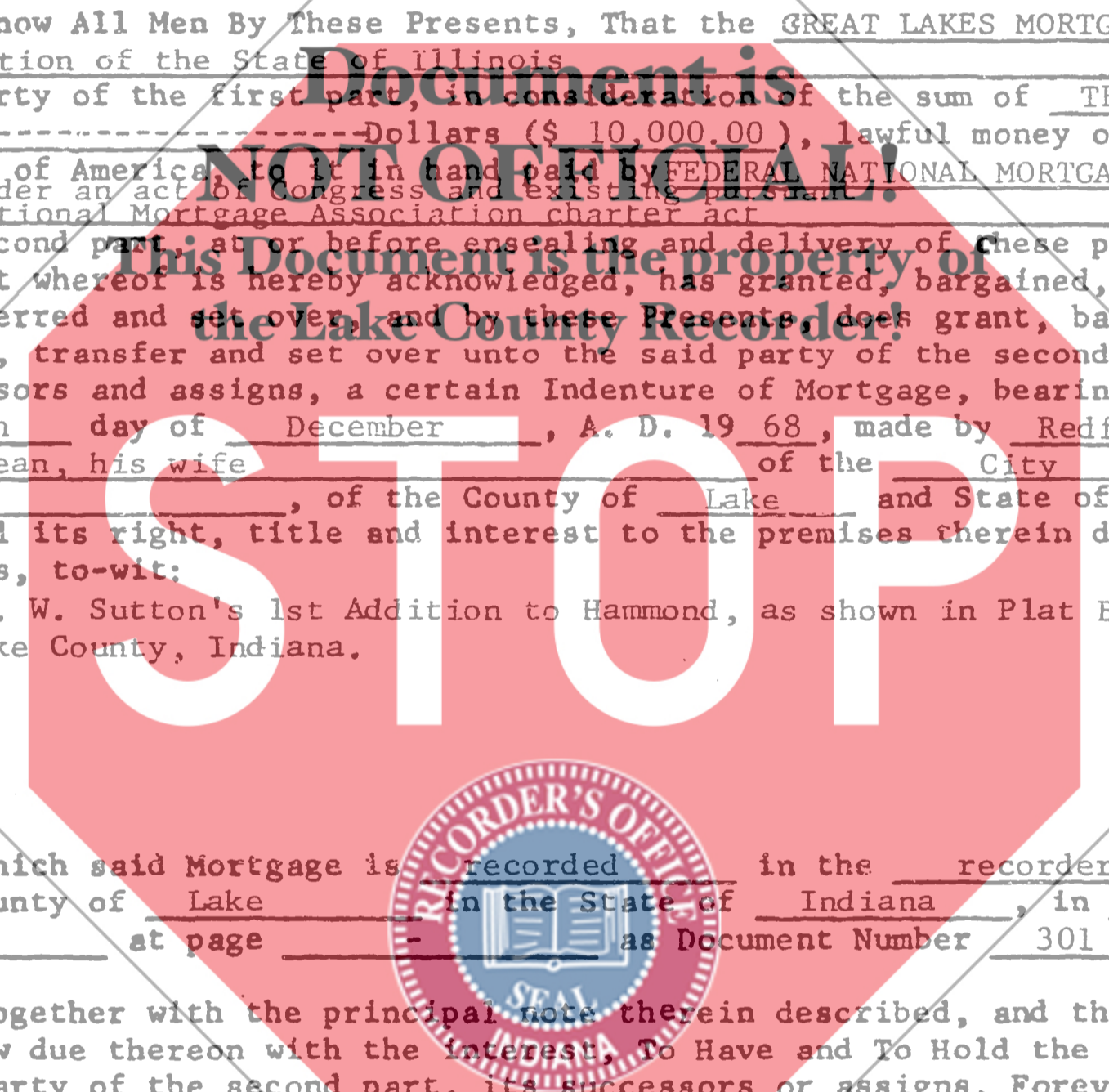
