ASSIGNMENT OF MORTGAGE

The party of the first part covenants that there is now due and owing upon said mortgage and note the principal sum of FOURTEEN THOUSAND FIVE HUNDRED AND NO/100 Dollars (\$ 14,500.00) with interest from January 23, 1969.

And It does hereby make, constitute and appoint the said party of the second part its true and lawful Attorney, irrevocably, in its name, or otherwise, but at its own proper costs and charges, to have, use and take all lawful ways and means for the recovery of the said money and interest, and, in case of payment to discharge the same as fully as it might, or could do, if these Presents were not made.
