This is to notify you that Louis W. & Katherine B. DeKrauze of Scottsdale, Arizona has complied with the withdrawal provisions of the Indiana Forest Tax Classification Law for the following described land:

28.60 acres in part of the NW 1/4 of Sec. 20, T34N, R9W, 2nd P.M., beginning at the S.W. corner of S.E. 1/4 of the N.W. 1/4 of said Sec. running thence N. 82° 11' E (Magnetic Bearing) on the S. line of said 1/4 sec. 209' 7/8" thence N. 1° 35' W. parallel with W. line of said SE 1/4 of NW 1/4 624' 10 3/4" thence S. 89° 10' W. 209' 7/8" to E. line of SW 1/4 of NW 1/4 of said sec. thence N. 1° 35' W. on said line 627' 11" to NE corner of said SW 1/4 of NW 1/4 thence S. 88° 55' W. on N line of said SW 1/4 of NW 1/4 957' 4 1/2" thence S. 2° 35' E 381' 4 1/2" thence S 11° 12' E. 347' 4 1/2" thence S. 6° 26' W. 423' 10 1/2"; thence S. 86° 18' W 120' 9 1/2"; thence S. 8° 48' E. 110' 3" to the S. line of said SW 1/4 of NW 1/4; thence N. 89° 11" E. on said line 1067' to the place of beginning, containing 31.67 acres (less 3.071 acres withdrawn 11-3-33) situated in Hanover Township, Lake County, Indiana.

When property is withdrawn from forest classification, our office must immediately notify the county recorder and the county auditor of the county where the land is located. Upon withdrawal the owner of the land previously classified shall make notation of the withdrawal in the records in the office of the county recorder.

Please note Section 17 of the enclosed law. There is a tax of \$5.00 per acres to be collected on this withdrawal. Kindly place the above described land back on the tax duplicate at its normal assessed valuation.
