AND, WHEREAS, it appears that notice of the time, terms and place of sale of said real estate was published and posted as required by law,

AND, WHEREAS, it appears that on the day named in the order of the Board of Commissioners, and in the notice as published and posted, the said County Auditor did offer said real estate for sale.

AND, WHEREAS, Edward Stack did then and there bid the sum of Five Hundred Twenty Eight dollars and ten cents, and that the County Auditor did then and there accept said bid.

AND, WHEREAS, it appears that Edward Stack did thereupon pay the amount of his bid to the County Treasurer of said county in cash.

AND, WHEREAS, the County Auditor did on the 27th day of January 1969 report his proceedings therein to the Board of Commissioners.

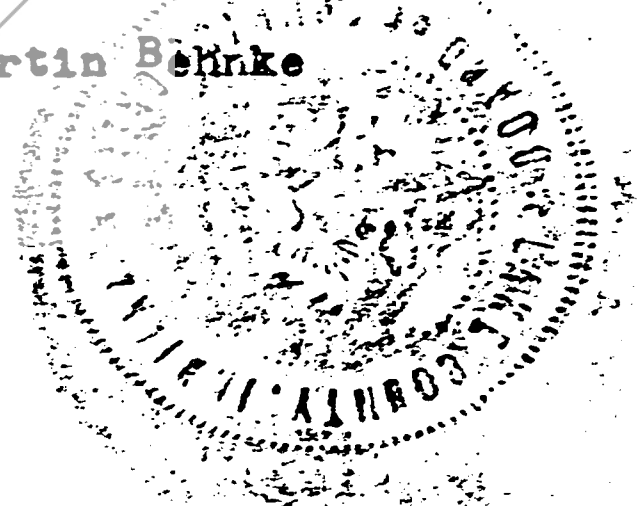
