FEBRUARY, 1969, upon the final account, petition to determine  
heirship and for authority to distribute estate, which account and

the first published notice to the heirs and creditors herein; all claims filed against the estate have been paid and discharged; neither said decedent nor his administrator was an employer of labor; all inheritance taxes and other taxes assessed against the estate have been paid; and said estate was not subject to federal estate taxes.

**STOP**

4. Genevieve Kahle, Evelyn Varlan and John A. Tramm are the only heirs at law of said decedent and is entitled to the balance of the assets of said estate which consists solely of the real estate of which decedent died seized and which is hereinafter described.



NOW, THEREFORE, IT IS ORDERED AND DECREED by the Court as follows:

1. Said account and petition are hereby in all things approved; and it appearing to the Court that the sole remaining assets of the estate is real estate, that there can be no distribution.

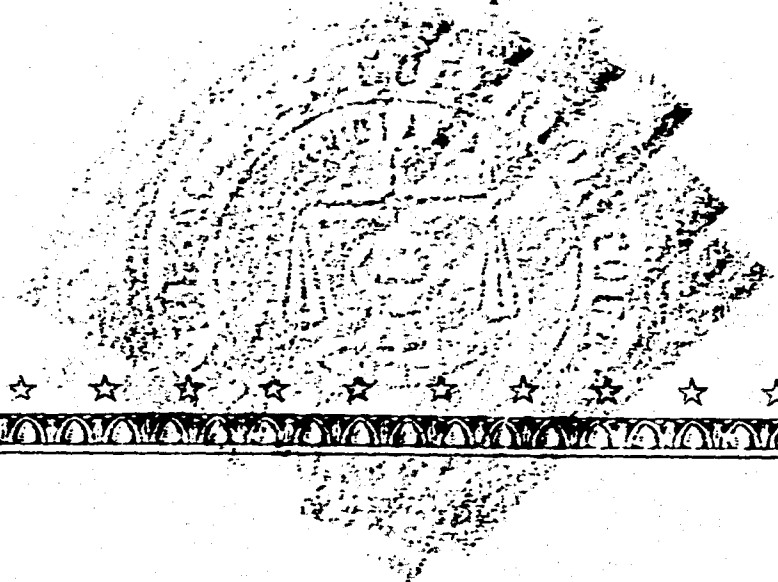
