Comes now Gertrude Rasheta, petitioner and widow of Eli G.  
Rashata, also known as Elie G. Rasheta, deceased, and files her

verified Petition for Widow's Allowance and For Order of No Admin-  
istration, which petition is in the words and figures following,

And the Court, having examined said petition, and being fully  
advised, finds that the facts stated in said petition are true;  
that the funeral charges of said decedent and the expenses of this  
proceeding have been paid; that a widow's allowance should be made  
to petitioner in the sum of Two Thousand Dollars (\$2,000.00); that  
the value of the gross estate of decedent less liens and encumbrances  
thereon, not including the homestead interest, is Thirteen Hundred  
Eighty Dollars (\$1,380.00); that said widow's allowance will exhaust  
the entire assets of the estate and said assets should be trans-  
ferred and set aside to the petitioner who, as widow of said decedent,  
is entitled to have the same vested in her, and that no administra-  
tion is necessary.

IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED by the Court:

1. That a widow's allowance in the sum of Two Thousand Dollars  
(\$2,000.00) is hereby made to Gertrude Rasheta, the widow of said  
decedent.

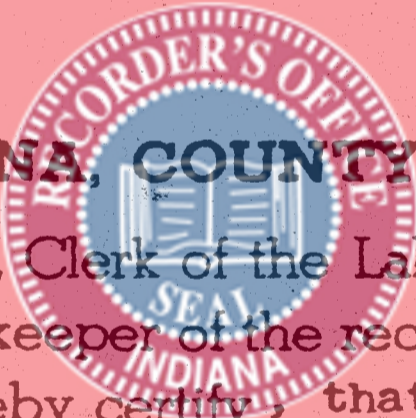
