M., in the Town of East Gary, Lake County, Indiana, described as beginning at a point on the South line of said Section 9, 259.6 feet West of the Southeast corner of the West 660 feet of said Section, thence Northeasterly along the Easterly right-of-way line of State Road #51 Interchange on a curve having a radius of 897 feet more or less a distance of 638.7 feet more or less; thence continuing along the same right-of-way boundary Northeasterly a distance of 524 feet more or less to an intersection with a North-South line which begins at a point on the South line of the said Southwest Quarter of Section 9 which is 335.07 feet East of the East line of the West 660 feet of said Section 9 and which runs North to the Little Calumet River at a point which is 310 feet East of the East line of the West 660 feet of said Section 9,
