MEMORANDUM OF AGREEMENT, MADE THIS 19th DAY OF March 19 69
BY AND BETWEEN ILLINOIS BELL TELEPHONE COMPANY, AN ILLINOIS CORPORATION WITH OFFICES AT
225 W. RANDOLPH STREET, CHICAGO, ILLINOIS, PARTY OF THE FIRST PART, HEREINAFTER CALLED THE
OWNER, AND Calumet Construction Corporation AN Indiana Corporation
CORPORATION WITH OFFICES AT 1247 169th Street, Hammond, Indiana 46324
PARTY OF THE SECOND PART, HEREINAFTER CALLED THE CONTRACTOR.

WITNESSETH:
WHEREAS THE PARTIES HERETO HAVE ENTERED INTO A CERTAIN AGREEMENT DATED THE 19th
DAY OF March 19 69 PROVIDING FOR THE CONSTRUCTION, FINISHING AND DE-
LIVERY BY THE CONTRACTOR TO THE OWNER OF THE FOLLOWING WORK, TO-WIT:
Alterations on the first and second floors
LOCATED ON PROPERTY DESCRIBED AS Lots 37, 38 and 39 in Lathams addition to the town of
Hammond, Lake County, Indiana

STREET, Hammond, INDIANA, IN ACCORDANCE WITH DRAWINGS AND SPECIFICATIONS.

AND WHEREAS IT IS THE DESIRE OF THE PARTIES TO MODIFY SAID CONTRACT BY THE ADDITION
OF SUPPLEMENTARY TERMS THERETO.

NOW, THEREFORE, IN CONSIDERATION OF THE PREMISES AND OF THE MUTUAL COVENANTS AND
AGREEMENTS HEREIN CONTAINED AND FOR THE SUM OF ONE (\$1.00) DOLLAR IN HAND PAID BY EACH
OF THE PARTIES TO THE OTHER AND OTHER GOOD AND VALUABLE CONSIDERATIONS, THE RECEIPT
WHEREOF IS HEREBY ACKNOWLEDGED BY EACH OF THE PARTIES HERETO, IT IS MUTUALLY AGREED
AS FOLLOWS:

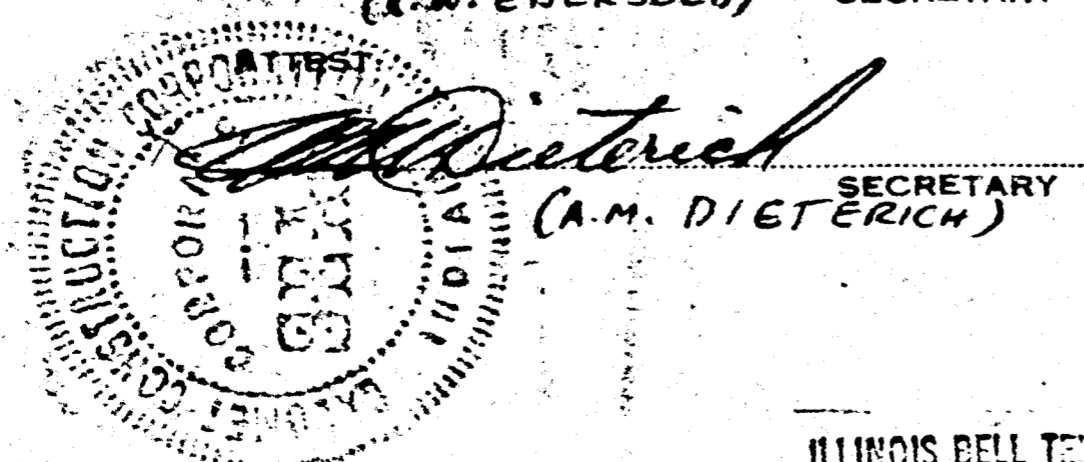
THAT SAID CONTRACT, ABOVE REFERRED TO, BE AND THE SAME IS HEREBY MODIFIED BY ADDING
THERETO A SUPPLEMENT, AS FOLLOWS: THE WORK CALLED FOR BY SAID CONTRACT SHALL BE PER-
FORMED, CONSTRUCTED, FINISHED AND DELIVERED TO THE OWNER, FREE FROM AND CLEAR OF ALL
LIENS, CLAIMS AND CHARGES WHATSOEVER AND ALL LIENS, CLAIMS OR CHARGES IN THE NATURE OF
MECHANICS' LIENS EITHER AGAINST THE SAID BUILDING OR PREMISES ON WHICH THE SAME SHALL BE
SITUATED, THE MATERIALS ENTERING INTO THE SAME, THE MONEY DUE OR TO BECOME DUE THERE-
UNDER, AND/OR AGAINST ANY OTHER PROPERTY OR THING UPON WHICH A LIEN IS GIVEN BY THE
STATUTE HEREINAFTER MENTIONED, EITHER IN FAVOR OF THE CONTRACTOR OR OF ANY PARTY, FIRM
OR CORPORATION ENTITLED TO SUCH LIEN UNDER AND IN ACCORDANCE WITH THE PROVISIONS OF
A CERTAIN ACT OF THE STATE OF INDIANA ENTITLED "AN ACT CONCERNING LIENS OF MECHANICS,
LABORERS, JOURNEYMEN, CONTRACTORS, AND SUBCONTRACTORS AND MATERIALMEN, AND DECLARING
AN EMERGENCY," IN FORCE MARCH 6, 1909, AS AMENDED FROM TIME TO TIME THEREAFTER, ARE HERE-
BY WAIVED AND FOREVER RELEASED.

THE SAID CONTRACT AFORESAID, AS HEREBY MODIFIED, IS IN ALL MATTERS AND THINGS HEREBY
RATIFIED, CONFIRMED, APPROVED AND ADOPTED AS AND FOR THE CONTRACT OF THE PARTIES HERETO.

IN WITNESS WHEREOF THE PARTIES HERETO HAVE HEREUNTO SET THEIR HANDS AND SEALS THE
DAY AND YEAR FIRST ABOVE WRITTEN.
