Exact Text of Amendment

(A) " Article 1. " The Gary Clergy Belief Society Inc., shall be formally recognized as the official instrument by which the Diocese of Gary fulfills entirely its obligation incurred when a Priest is ordained or incardinated under the title of " Diocese of Gary ". Furthermore, any priest who elects not to be a member of said Society, or lapses in membership by non-payment of dues, forfeits any claim on the Diocese of Gary for benefits, either partial or total disability or for retirement

priest is ordained, or incardinated under the title of " Diocese of Gary "/ Furthermore,  
any Priest who elects not to be a member of said Society, or lapses in membership by non-  
payment of dues, forfeits any claim on the Diocese of Gary, for benefits, either partial  
or total disability , or for retirement . "

St. Mark's Rectory, Gary, Indiana, and the secretary is hereby directed to give Notice thereof as required by law."

(B) At the members' meeting the members entitled to vote in respect of said amendment to the articles of incorporation, upon the call and notice required by law, did adopt the above amendment (s) by the affirmative vote of the holders of at least a majority of the members entitled to vote thereon.
