1. Due notice of the filing of said account and petition and of the hearing on the same were given to all of the heirs of said decedent and all persons interested in said estate, and the same are now properly before the Court for final action thereon.

2. The matters and things stated in said account and petition are true and said Executor has accounted for all assets of this estate coming into his hands.

3. More than six months have elapsed since the date of the first published notice to the heirs and creditors herein; no claims were filed against said estate and all debts and liabilities of said decedent and her estate have been paid or discharged; neither said decedent nor her Executor was an employer of labor as that term is defined in the Indiana Employment Security Act; all inheritance taxes, income taxes and gross income taxes assessed in said estate have been paid; and the federal estate tax has been paid.

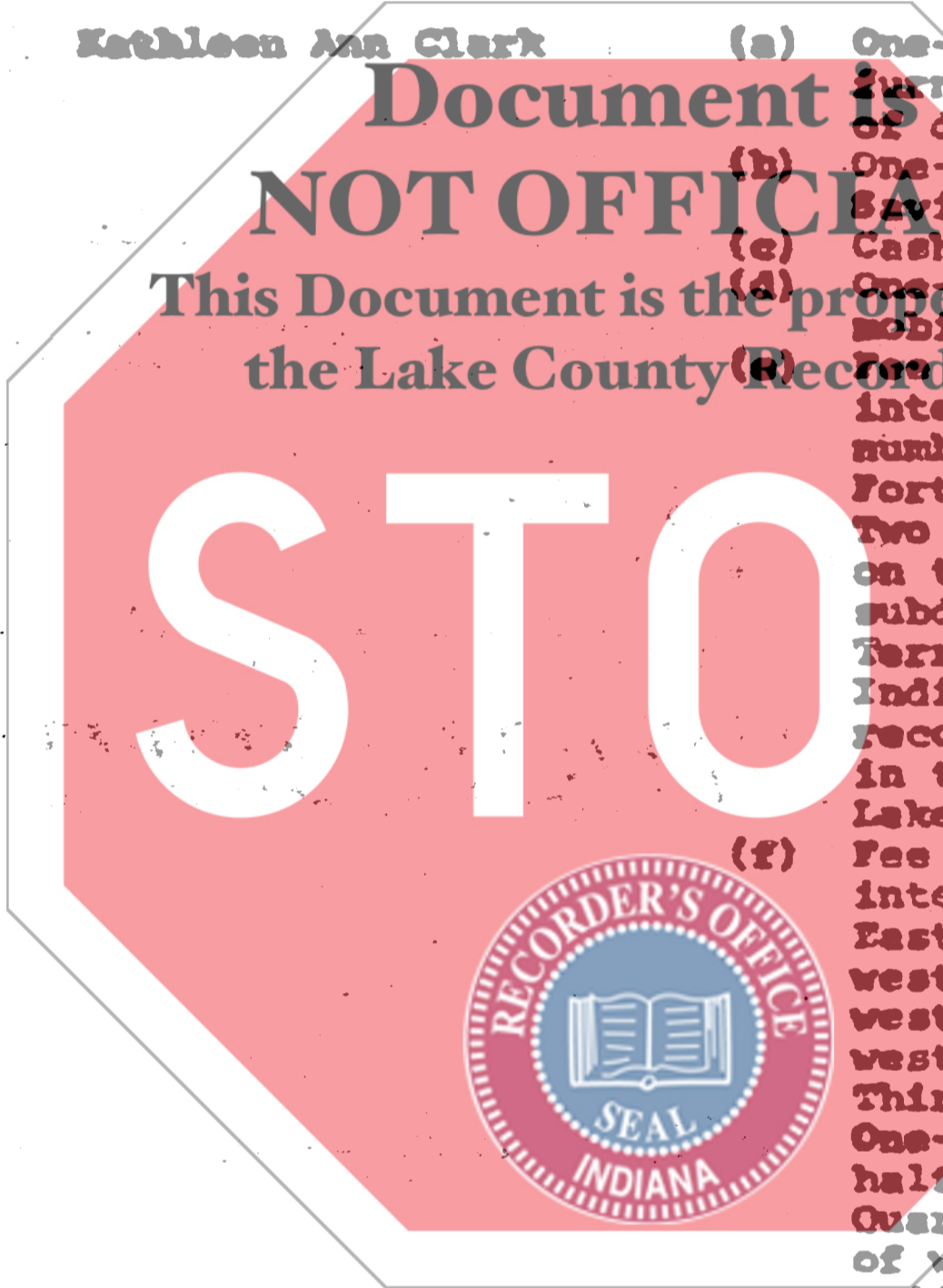
