
THE MORTEAGOR FURTHER COVENANTS that:

- 1. He is the owner of said premises in fee simple or such other estate as is stated herein.
- 2. He will pay the indebtedness as provided in said note and this mortgage. Privilege is reserved to prepay at any time, without premium or fee, the entire indebtedness or any part thereof not less that the amount of one installment, or one hundred dollars (\$100.00), whichever is less.
