GRANT OF EASEMENT AND RIGHT OF WAY

That for and in consideration of one dollar (\$1.00) and other good and valuable considerations, receipt whereof is hereby acknowledged, the Grantor does hereby give and grant unto the Grantee forever the right to construct and maintain a sewer line under and through, and a street and roadway over and upon, Grantors following described real estate in Lake County, Indiana, to-wit:

The North thirty (30) feet of The East 8 acres of that part of the Northwest quarter of the Southeast quarter, lying West of the East 660 feet thereof, except the South 515 feet, in Sec. 22, Twp. 36 North, Range 9 West of the 2nd P.M. in Lake County, Indiana; and The North thirty (30) feet of the West 2 acres of the East 10 acres of that part of the Northwest Quarter of the Southeast quarter, lying West of the East 660 feet thereof, except the South 310 feet, in Sec. 22a Twp, 36 North, Range 9 West of the 2nd P.M. in Lake County, Indiana; and, The North thirty (30) feet of the North half of the East half of the Northwest quarter of the Southeast quarter, except the East 130 feet of the South 155 feet, in Section 22, Twp. 36 North, Range 9 West of the 2nd P.M., in Lake County, Indiana.
