A PRELIMINARY RESOLUTION OF A  
PORTION OF FISHER STREET IN THE TOWN OF MUNSTER,  
LAKE COUNTY, INDIANA

WHEREAS, a certain portion of Fisher Street, in the Town of Munster, Lake County, Indiana, more particularly described below, has been sought to be vacated by the owner thereof, and

WHEREAS, said portion of Fisher Street is unnecessary to service adjoining or abutting property with municipal facilities, and

WHEREAS, it is in the best interests of the Town of Munster, Lake County, Indiana that said portion of Fisher Street be vacated,

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Town of Munster, Lake County, Indiana that a certain portion of Fisher Street, described as follows:

That portion of Fisher Street, being a strip of land approximately 40 feet in width and 190.67 feet in length, more or less, lying east of the east line of the right of way of the Pittsburgh, Cincinnati & St. Louis Railroad Company (also called Pennsylvania Railroad Company) north of the right of way of the Northern Indiana Public Service Company, west of the west line of Timrick Drive (extended) and south of Lot 40, Knickerboker Manor 4th Addition to Munster, all in the Town of Munster, Lake County, Indiana,

be and the same is hereby vacated, and

BE IT FURTHER RESOLVED, that the 15th day of April, 1963 at 8:00 o'clock P.M., at the Town Hall of Munster, Indiana, is hereby set as the time and place for receiving and hearing remonstrances from persons interested in or affected by such proceeding, and

BE IT FURTHER RESOLVED, that publication of notice of the adoption of this Preliminary Resolution and the date, time and place for receiving and hearing remonstrances be published according to law, and at said hearing, the Board of Trustees of the Town of Munster, Lake County, Indiana shall affirm, modify or rescind this Preliminary Resolution.
