for the sum of \$10.00 and other good and valuable consideration Dollars
the following described REAL ESTATE in Lake County, in the

State of Indiana, to-wit:
Part of the North half of the fractional Northwest quarter of Section 19, Township 35 North, Range 9 West of the 2nd Principal Meridian in Lake County, Indiana, described as beginning at a point on the North line of said Northwest quarter, which point is 658.99 feet West of the Northeast corner thereof, said point of beginning being the northwest corner of the tract conveyed to Harold F. Lohse and Nellie Lohse, husband and wife, in Quit Claim Deed dated October 17, 1968 and recorded June 30, 1969, as Document 22282; thence West along the North line of said Northwest quarter 313 feet to the center line of a ditch; thence South 18 degrees 13 minutes West along said center line 63 feet; thence South 35 degrees 48 minutes West along said center line 51 feet; thence South 9 degrees 23 minutes East along said centerline 497 feet; thence South 43 degrees 08 minutes East along said center line 208.15 feet; thence South 27 degrees 41 minutes East along said center line 200 feet; thence South 18 degrees 45 minutes East along said center line 186 feet; thence South 9 degrees 28 minutes East along said center line 80.8 feet to the point of intersection between the West line of the property conveyed to Harold F. Lohse and Nellie Lohse, husband and wife, aforesaid, and the center line of said ditch; thence North along the West line of the property conveyed to Harold F. Lohse and Nellie Lohse, husband and wife, to the place of beginning.

This deed is given to correct the description contained in a prior corrective deed in which F. Louis DeLong and Bertha Ann DeLong, husband and wife appeared as Grantors, and Lorraine M. Mills and Richard C. Mills, her husband, appeared as Grantees, said deed being dated October 17, 1968, and recorded June 30, 1969, as Document 22283. The purpose of this deed is to correct the Southeast point of the property therein described which was erroneously shown to be 673 feet West of the East line of the Northwest quarter.
