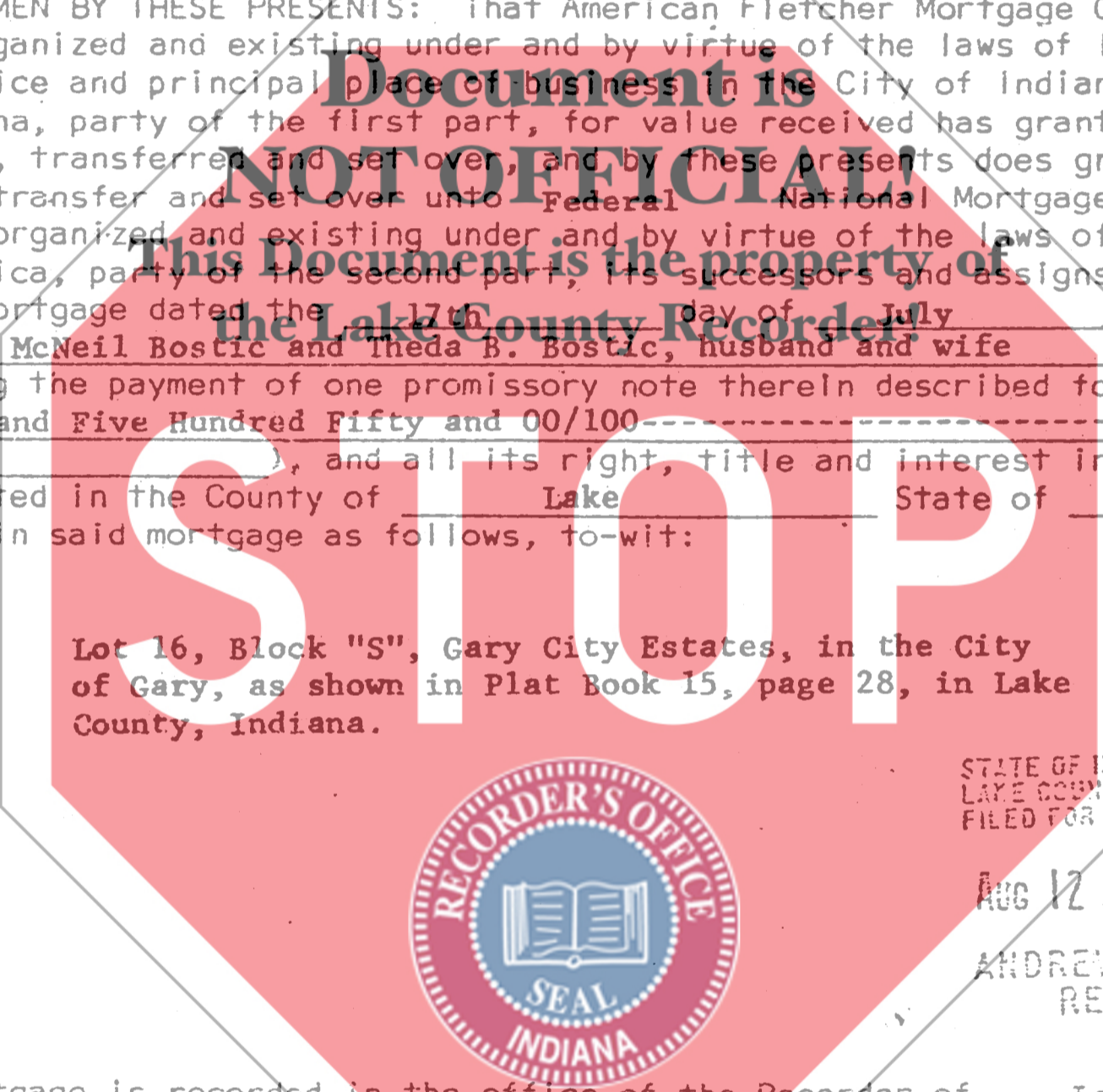

Lot 16, Block "S", Gary City Estates, in the City of Gary, as shown in Plat Book 15, page 28, in Lake County, Indiana.

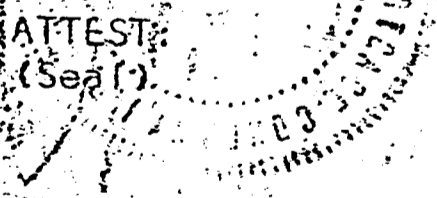

TO HAVE AND TO HOLD the same unto the said party of the second part, its successors and assigns, forever, subject only to the provisions in the said indenture of mortgage contained.

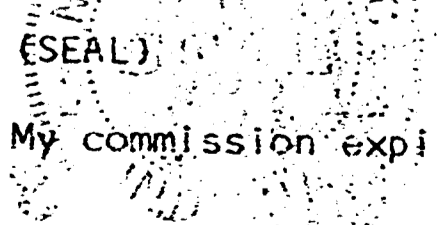
