good and valuable consideration, the receipt whereof is hereby acknowledged, the following described Real Estate

is Lake County, in the State of Indiana, to wit: That part of the West half
of the Northwest Quarter of Section 27, Township 32 North, Range 9 West of the
2nd Principal Meridian, described as follows: From a point in the original center
line of the Indiana Harbor Railroad, now the New York Central Railroad, which is
the center line between the 2 main tracks as now located, said point being 1584.4
feet South of the North line of said Section 27, measured along said original
center line, measure Westerly along a line which is perpendicular to said original
center line a distance of 72.5 feet to the place of beginning; thence continuing
Westerly along last mentioned perpendicular line a distance of 200.5 feet, more or
