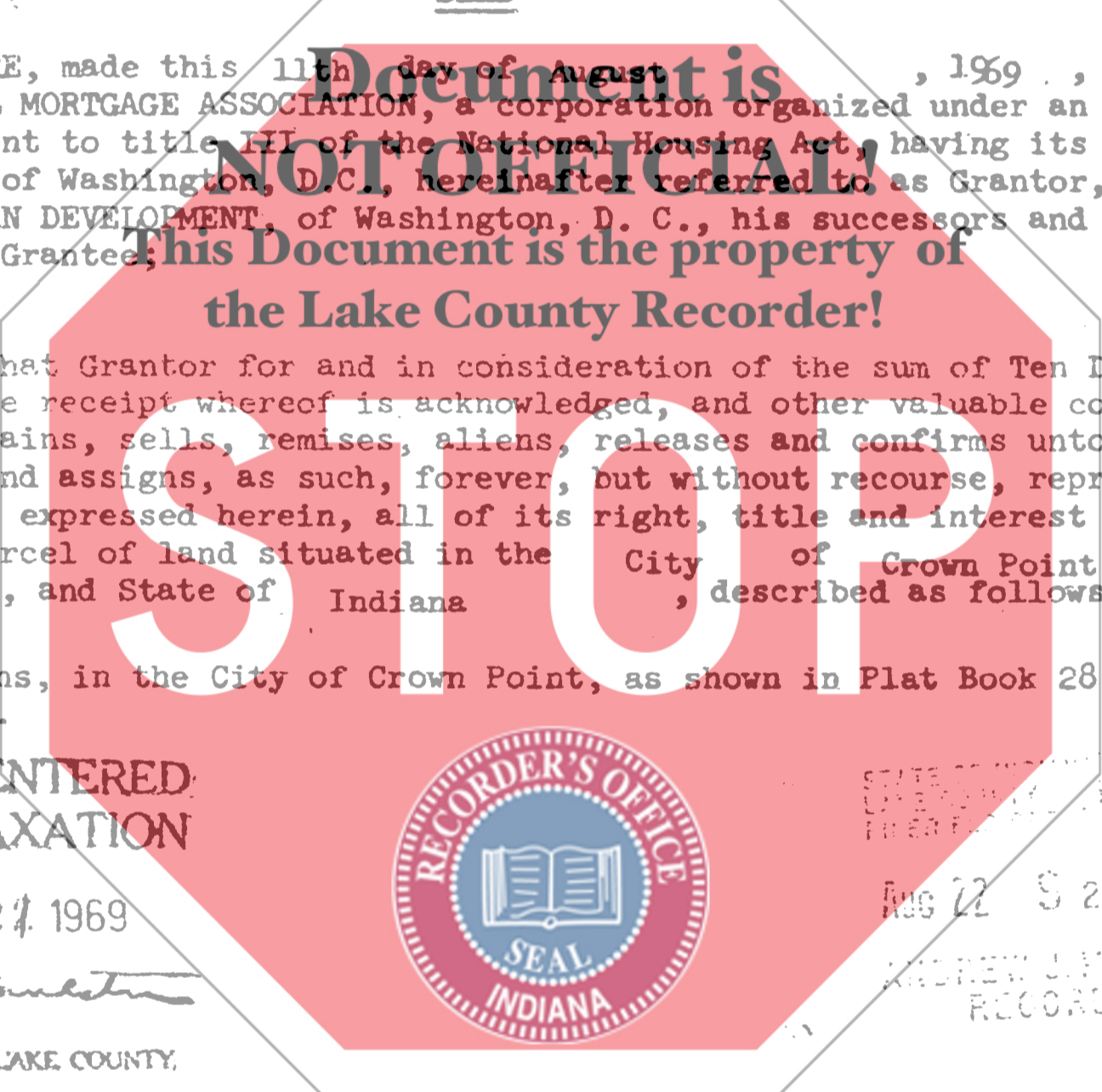

DEED

THIS INDENTURE, made this 11th day of August, 1969, between GOVERNMENT NATIONAL MORTGAGE ASSOCIATION, a corporation organized under an Act of Congress and existing pursuant to title III of the National Housing Act, having its principal office in the City of Washington, D.C., hereinafter referred to as Grantor, and SECRETARY OF HOUSING AND URBAN DEVELOPMENT, of Washington, D. C., his successors and assigns, hereinafter called Grantee;



WITNESSETH, that Grantor for and in consideration of the sum of Ten Dollars (\$10.00) paid by Grantee, the receipt whereof is acknowledged, and other valuable consideration, hereby grants, bargains, sells, remises, aliens, releases and confirms unto Grantee and to his successors and assigns, as such, forever, but without recourse, representation or warranty, except as expressed herein, all of its right, title and interest in and to that certain tract or parcel of land situated in the City of Crown Point, county of Lake, and State of Indiana, described as follows, to wit:

Lot 10, Walnut Gardens, in the City of Crown Point, as shown in Plat Book 28 Page 47, in Lake County, Indiana.

Grantor also assigns and transfers unto Grantee herein, all of Grantor's claims and notes, and the judgment, if any, thereof representing the indebtedness heretofore secured by liens on the property hereinabove described, and which liens were heretofore foreclosed;

Together with all the right, title and interest of the undersigned in and to the deficiency arising from the sale of said property on the 18th day of April 1969, pursuant to the statutes of the State of Indiana, and all the right, title and interest of the undersigned in and to that certain note and mortgage dated the 11th day of June, 1966.

Subject property was vested in and acquired by the GOVERNMENT NATIONAL MORTGAGE ASSOCIATION, September 1, 1968, pursuant to the provisions of Public Law 90-448, the Housing and Urban Development Act of 1968, notice of which was published in the Federal Register at 33 F.R. 11035.

TO HAVE AND TO HOLD the premises as before described, with the appurtenances, unto the said Grantee, his successors in such office, as such, and his or their assigns, forever. And the Grantor, for itself and its successors and assigns, does covenant, grant, bargain and agree to and with the said Grantee, his successors and assigns, that Grantor has not heretofore done, committed or wittingly or willingly suffered to be done or committed, any act, matter or thing whatsoever, whereby the premises hereby granted, or any part thereof, is, are or shall be charged or encumbered in title, estate or otherwise howsoever.

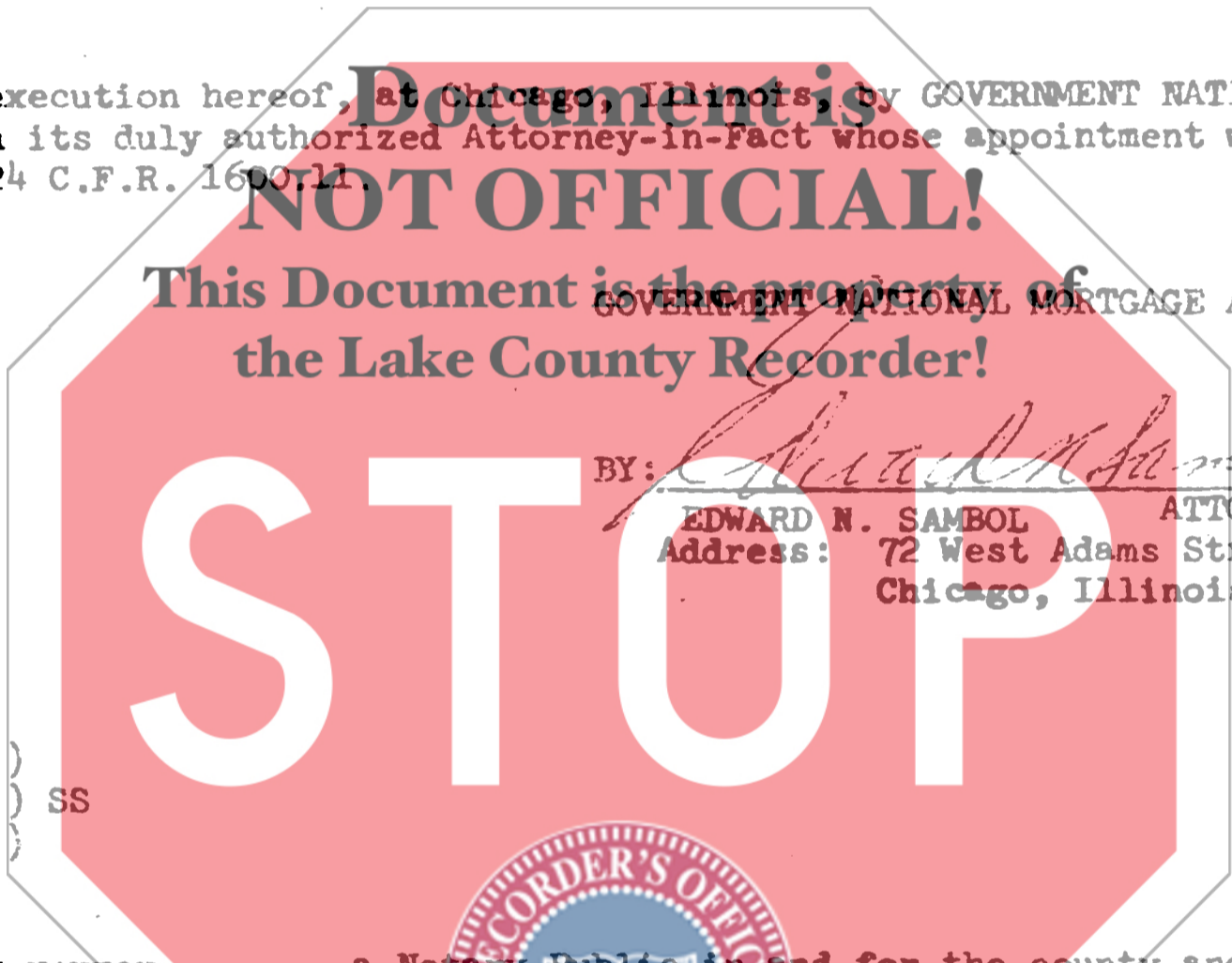
