ASSIGNMENT OF MORTGAGE

Harris, his wife, of the City of Gary, of the County of Lake and State of Indiana, and all its right, title and interest to the premises therein described, as follows, to-wit:

Together with the principal note therein described, and the money due or to grow due thereon with the interest, To Have and To Hold the same unto the said party of the second part, its successors or assigns, Forever, subject only to the provisos in the said Indenture of Mortgage contained:

The Party of the first part covenants that there is now due and owing upon said mortgage and note the principal sum of EIGHTEEN THOUSAND AND NO/100 Dollars (\$ 18,000.00) with interest from September 3, 1969

And It does hereby make, constitute and appoint the said party of the second part its true and lawful Attorney, irrevocably, in its name, or otherwise, but at its own proper costs and charges, to have, use and take all lawful ways and means for the recovery of the said money and interest, and, in case of payment to discharge the same as fully as it might, or could do, if these Presents were not made.
