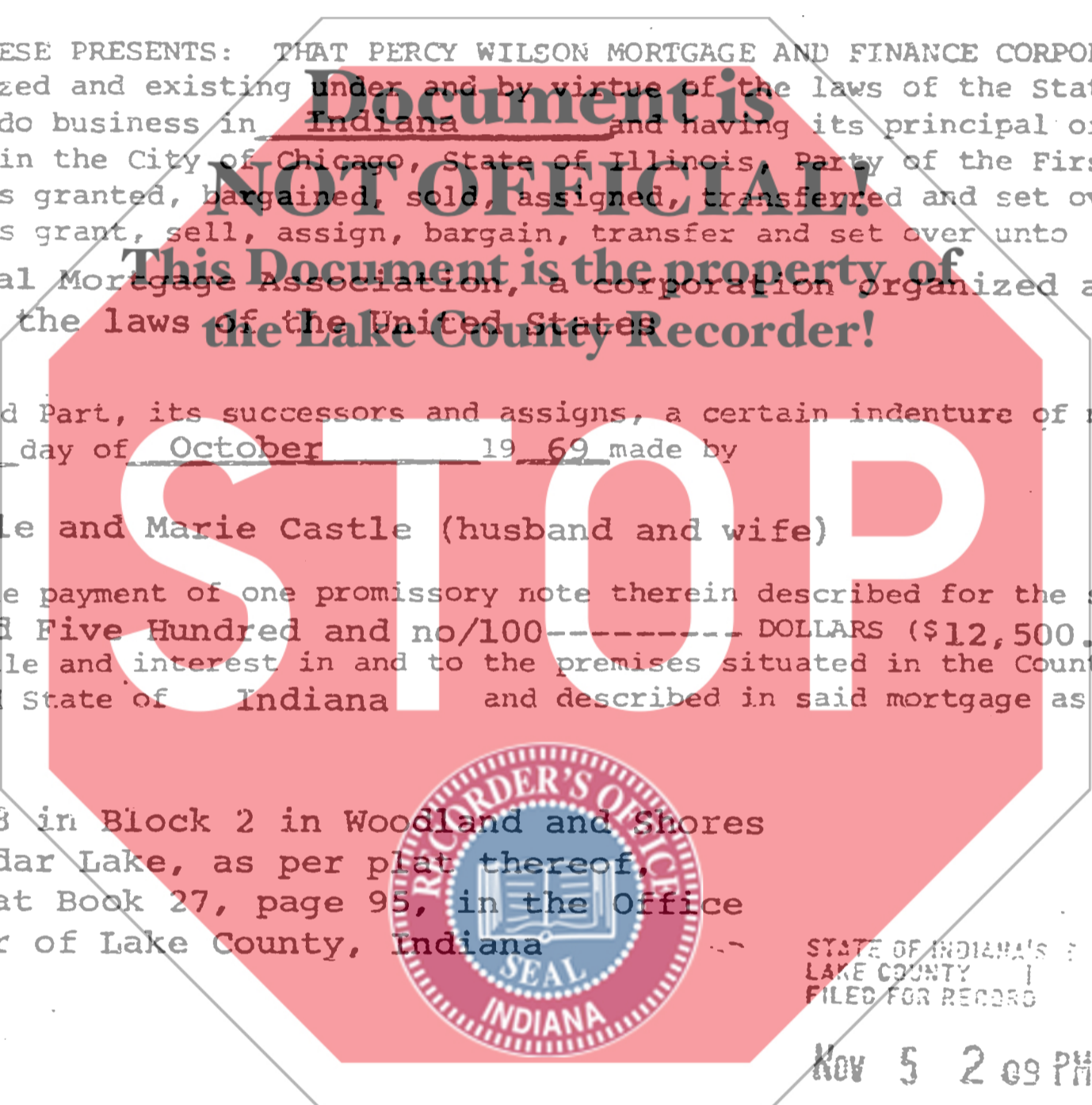

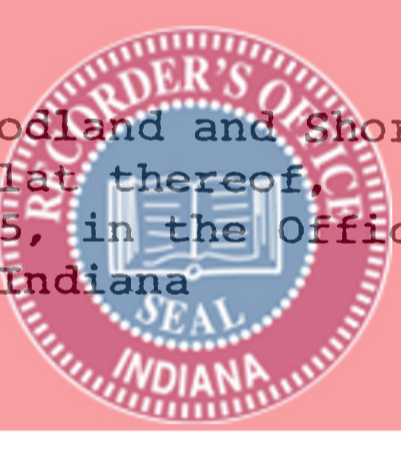


Party of the Second Part, its successors and assigns, a certain indenture of mortgage dated the 13th day of October 19 69 made by
