years after date, with interest thereon as provided in said note, said principal and interest being payable at the office of the Mortgages in the City of Hobart, Indiana, in regular monthly installments of TNO HUNDRED FIFTY-SIX AND 80/100-

plus taxes and insurances, each payable on or before the first day of each calendar month hereafter, all of which indebtedness the Mortgagors severally promise and agree to pay to the order of the Mortgagee, all without relief from valuation and appriasement laws and with attorney's fees.

The Mortgagors do hereby further covenant and agree as follows:

- 1. That the Mortgagors will, until the debt hereby secured is fully satisfied, pay all taxes and assessments levied on said premises and pay all premiums for keeping all insurable property covered hereby insured against loss and damage by fire, windstorm, extended coverage and war risk insurance with such insurers and in such amount and manner as shall be, in the judgment of the Mortgageo, necessary and proper. The Mortgages may, in case of failure of the Mortgagers so to do, pay any claim, lien or incumbrance or purchase any tax title or claim against the premises, make any repairs necessary to preserve the security intended to be given by this mortgage and may obtain complete abstracts of title of said real estate and such continuations thereof, as in the judgment of the Mortgagee, may be required. at any time while any part of the deb! hereby secured remains unpaid, and all sums so paid shall become immediately due to the Mortgages, shall be added to and become a part of the indebtedness secured hereby and shall bear interest at the rate of eight per cent (8%) per annum until paid.
- 2. To exercise due diligence in the operation, management and occupation of said real estate and the improvements thereon, and not to commit waste or allow the same to be committed on said premises, and to keep said real estate and the improvements thereon in their mesent condition and repair, normal and ordinary depresiation alone excepted, and not to commit or permit to be committed on said premises any illegal or immoral acts.
- 3. Said mortgaged premises shall not be sold or transferred without the written consent of the Mortgagee, and no contract or agreement shall be entered into by the Mortgagors whereby any one may acquire the right to a lien, mortgage or other incumbrance upon the mortgained premises, without written consent of the Mortgagee first had and obtained.
- 4. Upon default in any payment provided for by any evidence of indebtedness secured hereby, or in the event of a default by the Mortagants in the performance of any one or more of the covenants and agreements herein contained, or upon the institution of any legal proceeding to enforce a mortgage or other lien upon the mortgaged property, or if a petition in bankruptcy shall be filed by or against the Mortgagors or if the Mortgagors shall in any way be adjudged insolvent or shall make an assignment for the benefit of creditors, or if there shall exist any tien or incumbrance on the marigaged real estate superior to the lien of this marigage, or if said marigaged property shall be levied upon by virtue of any execution, citauhment or other writ, or shall come into the possession of or be ordered sold by the officer of any court, or if the Mariagons shall abandon the marigaged property, then the entire indebtedness secured hereby shall, at the option of the Martgagee, become and be immediately thus and payable, without notice or demand, and thereupon the Martgagee shall be entitled to the immediate possession of said marigaged property and the rents, issues, income and profits therefrom, with or without foreclosure or other proceedings, and shall also be entitled to collect said indebtedness, to foreclose this martgage and to enforce any of its rights hereunder, by proper legal or equitable proceedings. In any cuit or proceeding to foreclose this mortgage, or to enforce or protect the Mortgagee's rights hereunder, the Mortgagee in addition to any other remedy, and regardiess of the value of the martgaged property or the solvency of the Mortgagors, shall be entitled to the appointment of a receiver, to take possession of and protect said property and collect the reats and income, and apply the same as provided by law. In case of a foreclosure of this marigage the abstract of title shall be the absolute property of the Marigages.

No failure on the part of the Marigages to exercise any of its rights bereunder for defaults or breaches of covenants shall be constitued to prejudice its rights in the event of any other or subsequent default or breach of covenant, and no delay on the part of the Mortgages in exercising any of such rights shall be construed to preclude it from the exercise thereof at any time during the continuance of any such descrift or breach of covenum, and the Mortgages may enforce any one or more remedies hereunder successively or concurrently of its eption.
