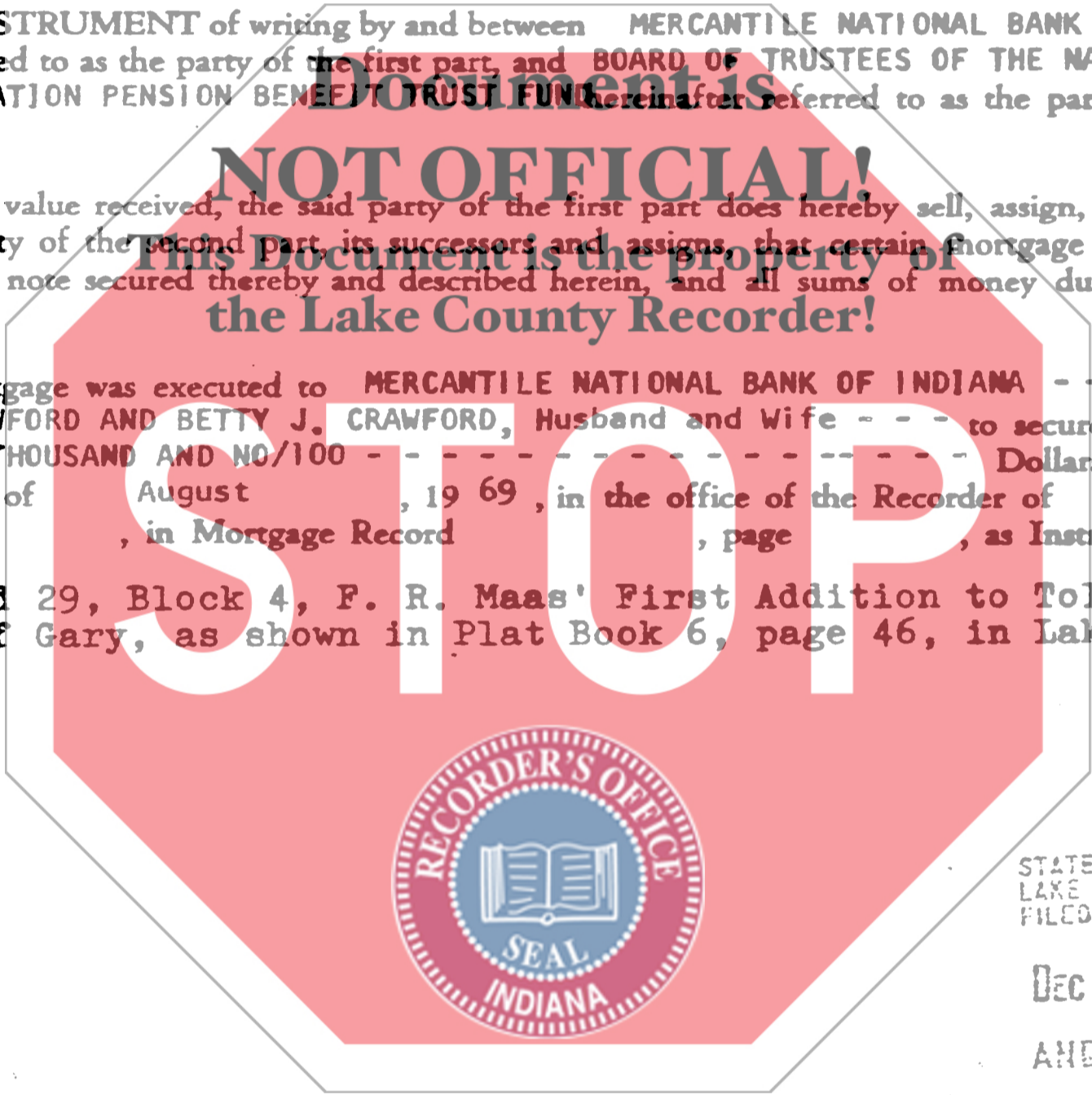
Assignment of Mortgage

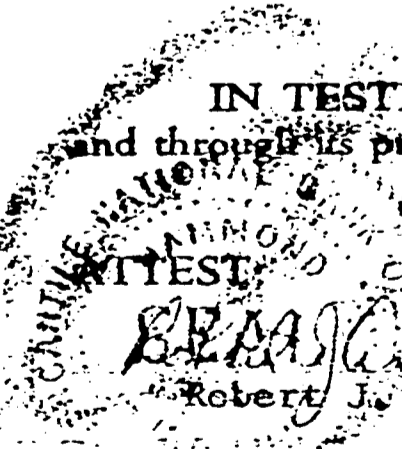
