INDEMNIFYING MORTGAGE

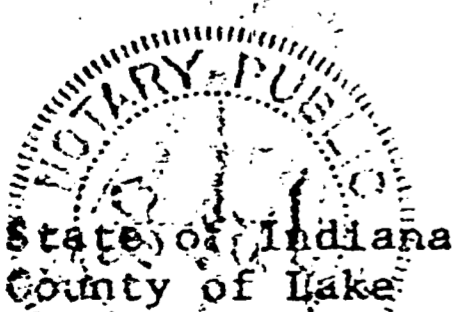
THIS INDENTURE WITNESSETH, That John Anton, Jr. and Joy Anton, husband and wife and (husband and wife) Brooks Gorden and Marian Gorden of Lake County, in the State of Indiana, hereby mortgage and warrant to the Bank of Indiana, National Association, Lake County, Indiana, the following described property in the County of Pulaski and State of Indiana to wit:
