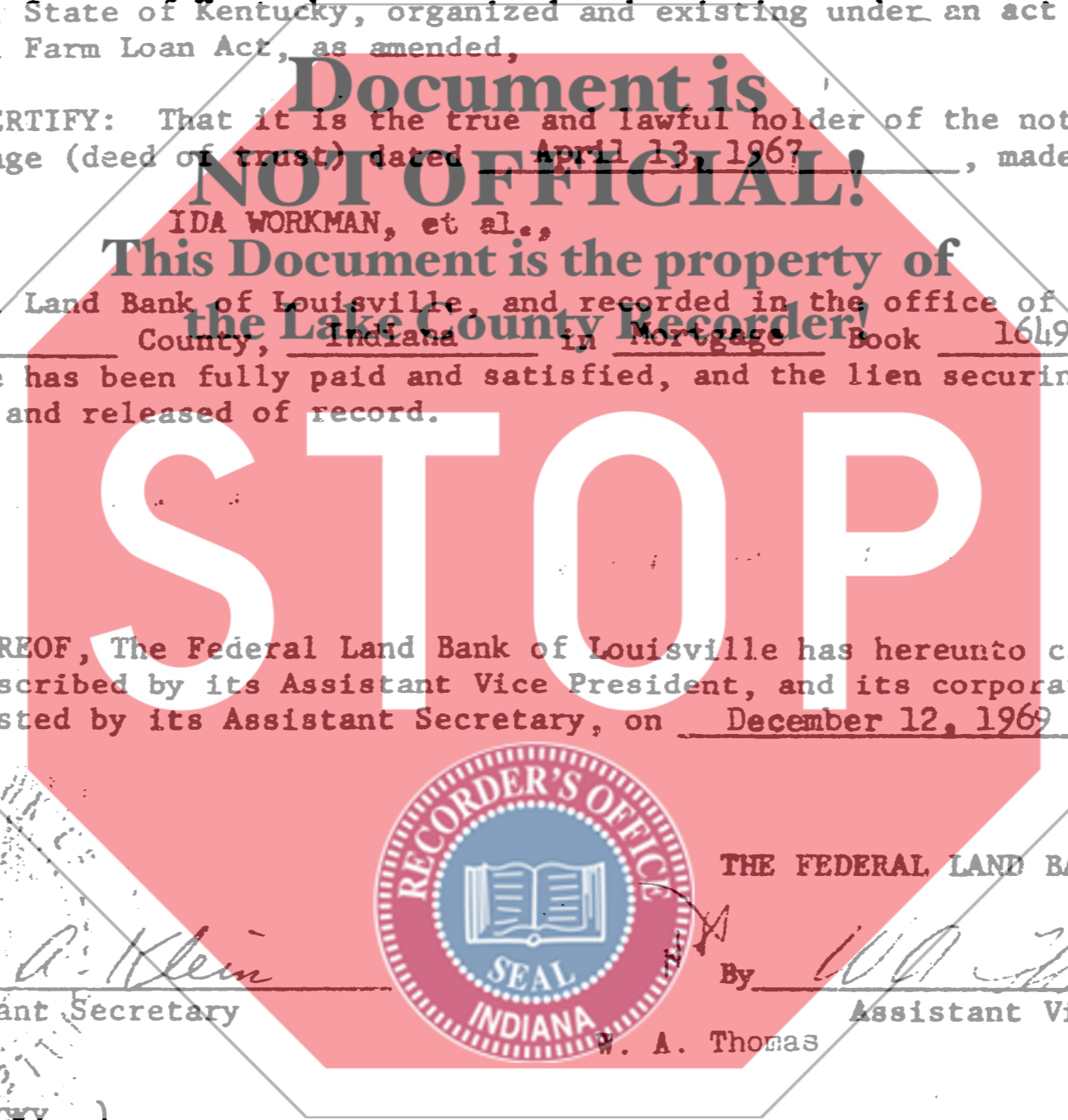
RELEASE OF MORTGAGE (DEED OF TRUST)
