Lot 135, The Park 4th Addition to the Town of Griffith, as shown in Plat Book 37, page 4 In Lake County, Indiana.

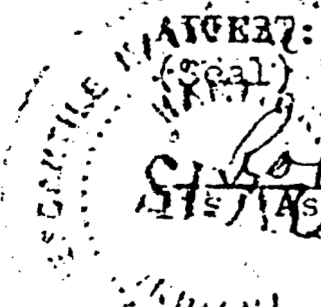

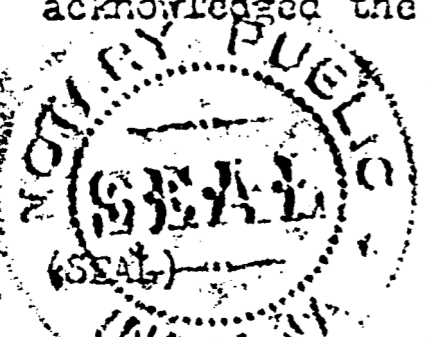
