ASSIGNMENT OF MORTGAGE

11,500.00 (\$ 11,500.00), lawful money of the United States of America, to it in hand paid by Metropolitan Life Insurance Company, a corporation of the State of New York, the party of the second part, at or before the ensembling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, transferred and set over unto the party of the second part, its successors and assigns, a certain Indenture of Mortgage, bearing date the 29th day of January, A.D. 19 70,

made by General Rollins and Mae Bell Rollins, his wife of the City of East Chicago, of the County of Lake and State of Indiana, and all its right, title and interest to the premises therein described, as follows, to-wit:

Part of Lot 14 in Block 16 in Indiana Harbor Homes Company's Estension to Sunnyside Addition to East Chicago, Indiana, being a subdivision of part of the Southeast 1/4 of Section 22, and part of the Northeast 1/4 of Section 27, Township 37 North, Range 9 West of the Second Principal Meridian, in East Chicago, Lake County, Indiana, being that part of said Lot 14 lying Northwesterly of the corner line of an existing party wall and its' prolongation, said center line of existing party wall and its' prolongation being 85.44 feet East of the Northwest corner of said Lot as measured along the North line of said lot, and 39.22 feet Southeasterly of the Southwest corner of said lot as measured along the Southwesterly line of said lot.

And It does hereby make, constitute and appoint the said party of the second part its true and lawful Attorney, irrevocably, in its name, or otherwise, but at its own proper costs and charges, to have, use and take all lawful ways and means for the recovery of the said money and interest, and, in case of payment to discharge the same as fully as it might, or could do, if these Presents were not made.
