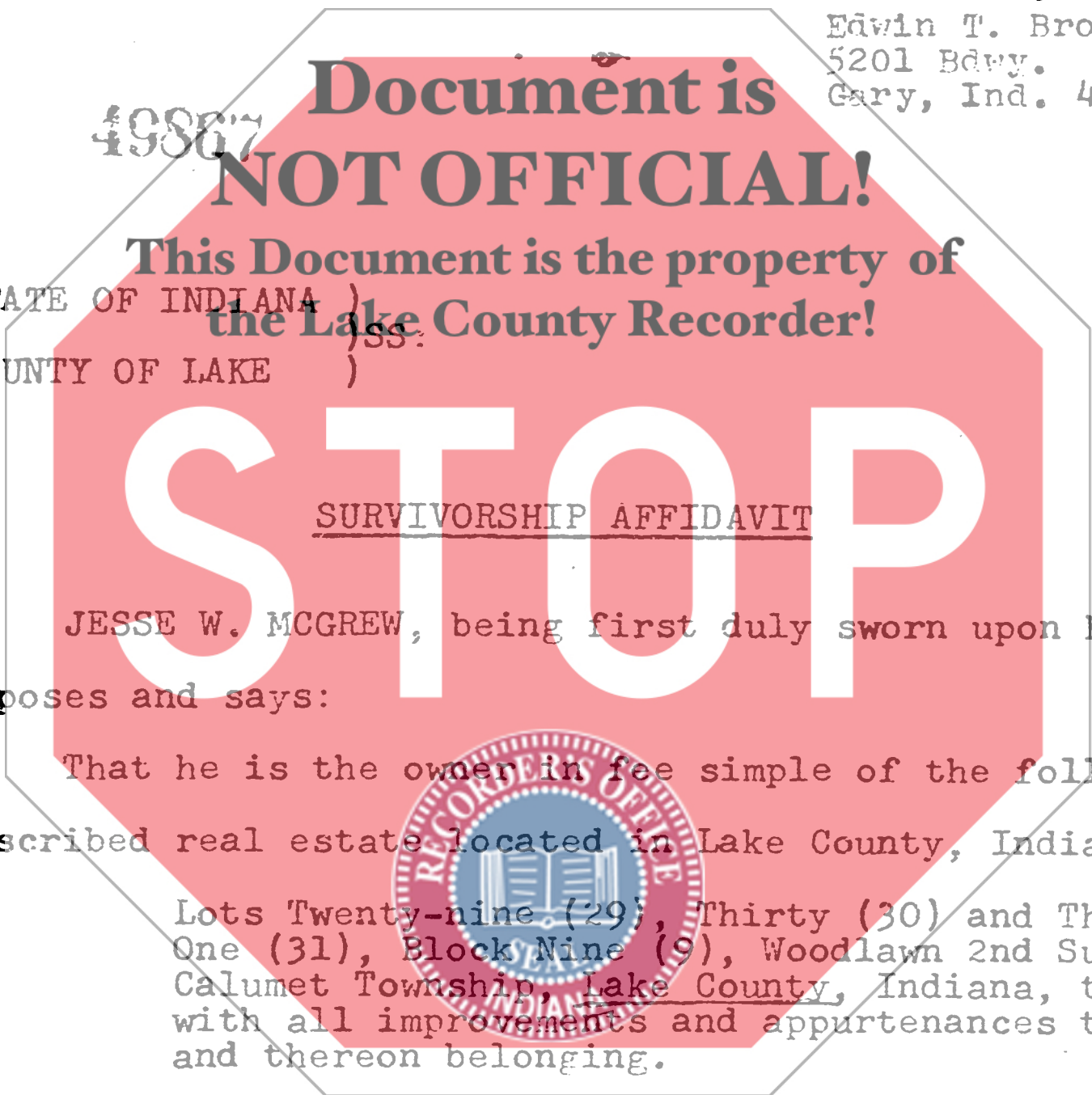

by the entireties, to said real estate.

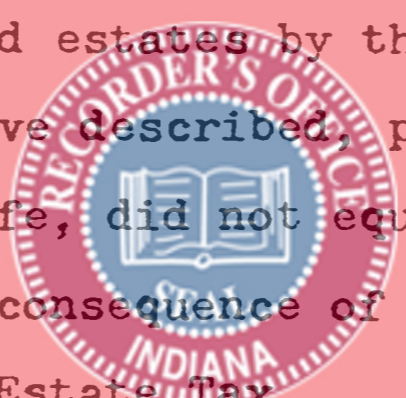
That the marital relationship which existed between said
