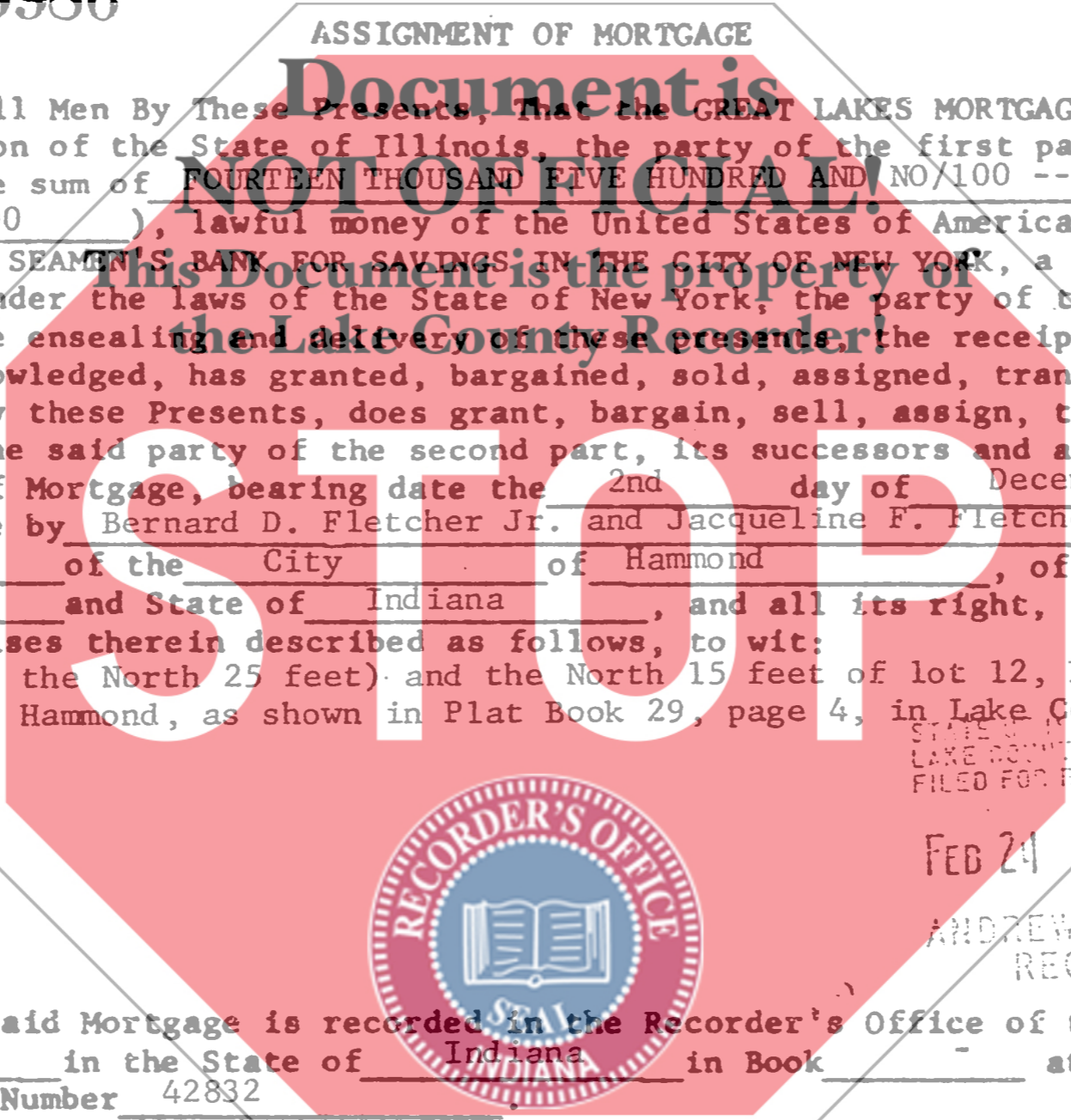

ASSIGNMENT OF MORTGAGE
