DONALDSON CALHOUN & ESSIE Mortgagor to said First National Bank of East Chicago,

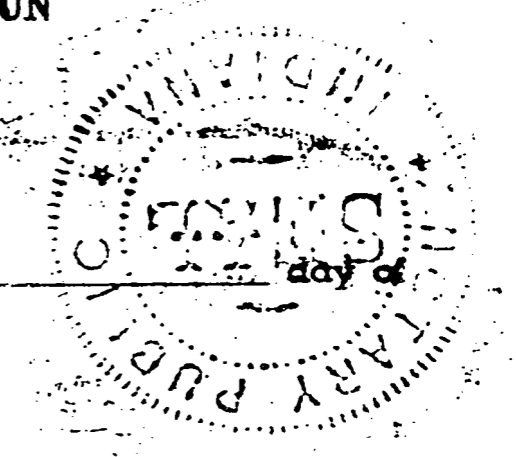
Indiana in the sum of \$ 6985.20 and is also given to secure all indebtedness or liability, of every
