FRANK & MARGARET HUSARIK Mortgagee to said First National Bank of East Chicago.

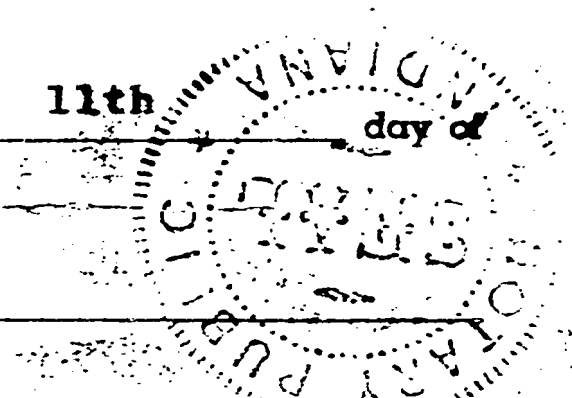
