1. He is the son of WALTER BRZENK, who was the owner of following described real estate:

2. WALTER BRZENK died, intestate, at East Chicago, Lake County, Indiana, on December 18, 1969.

3. WALTER BRZENK was married but once and then to BERTHA BRZENK, and of this marriage the following children were born, namely: THEODORE BRZENK, MARY PAPPAS, RAYMOND BRZENK, GENEVIEVE BRZENK, EUGENE BRZENK, WALTER BRENK (this affiant), JOAN BRZENK, STELLA ZARALKA, PATRICIA MATTHEWS, and CHESTER BRZENK. WALTER BRZENK and BERTHA BRZENK never adopted any child or children.
