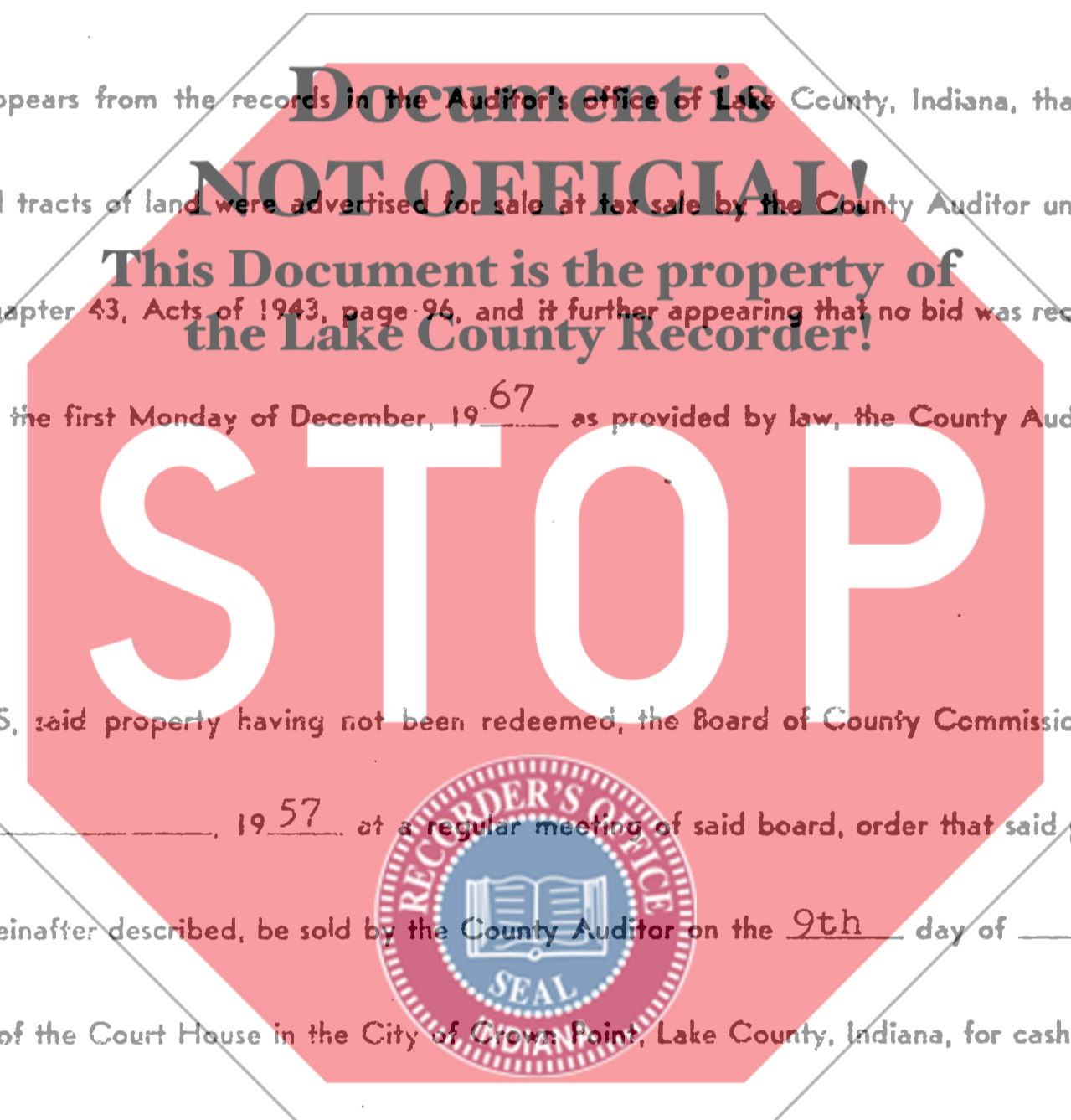
AND, WHEREAS, it appears that notice of the time, terms and place of sale of said real estate was published and posted as required by law,

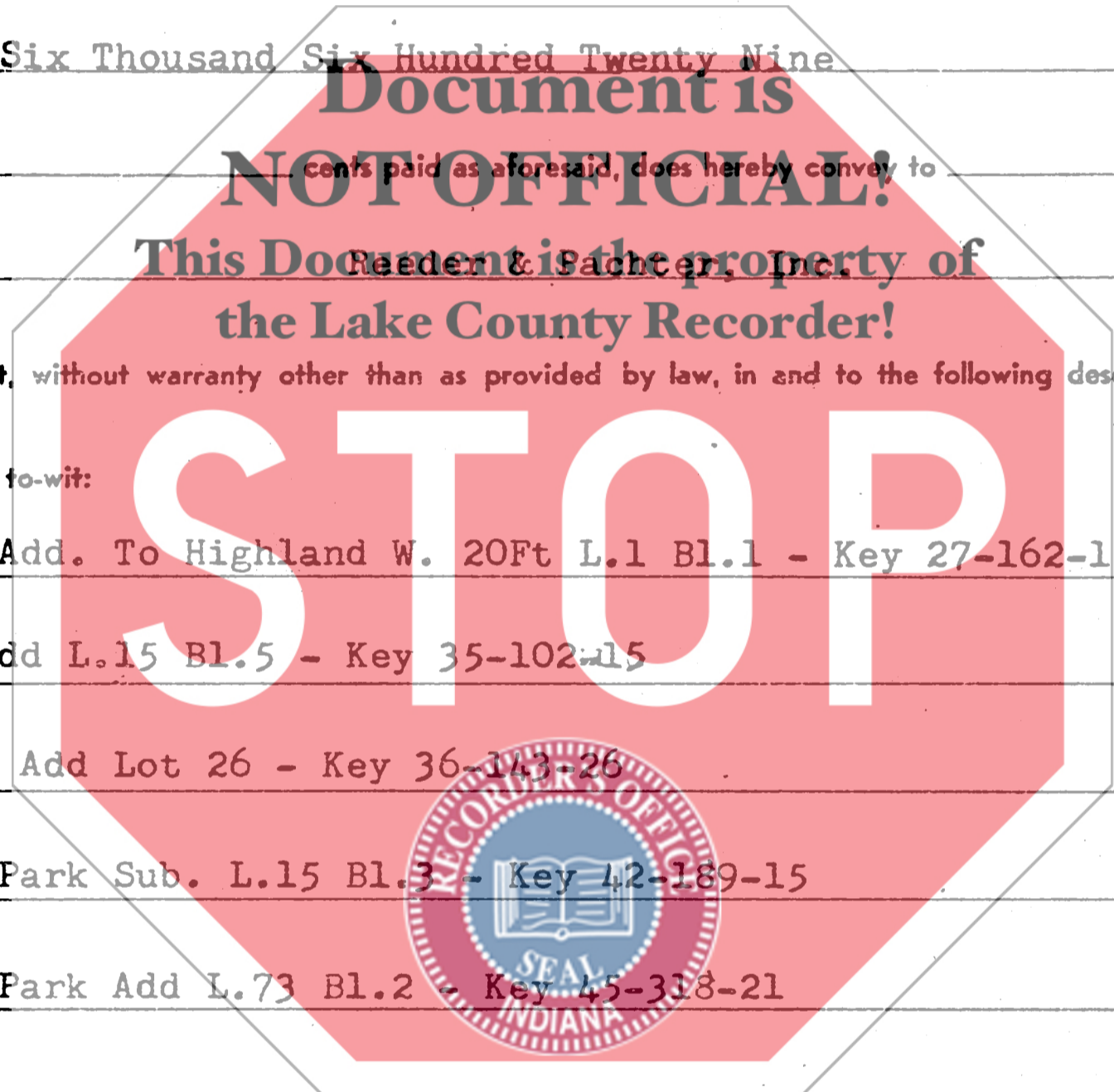
