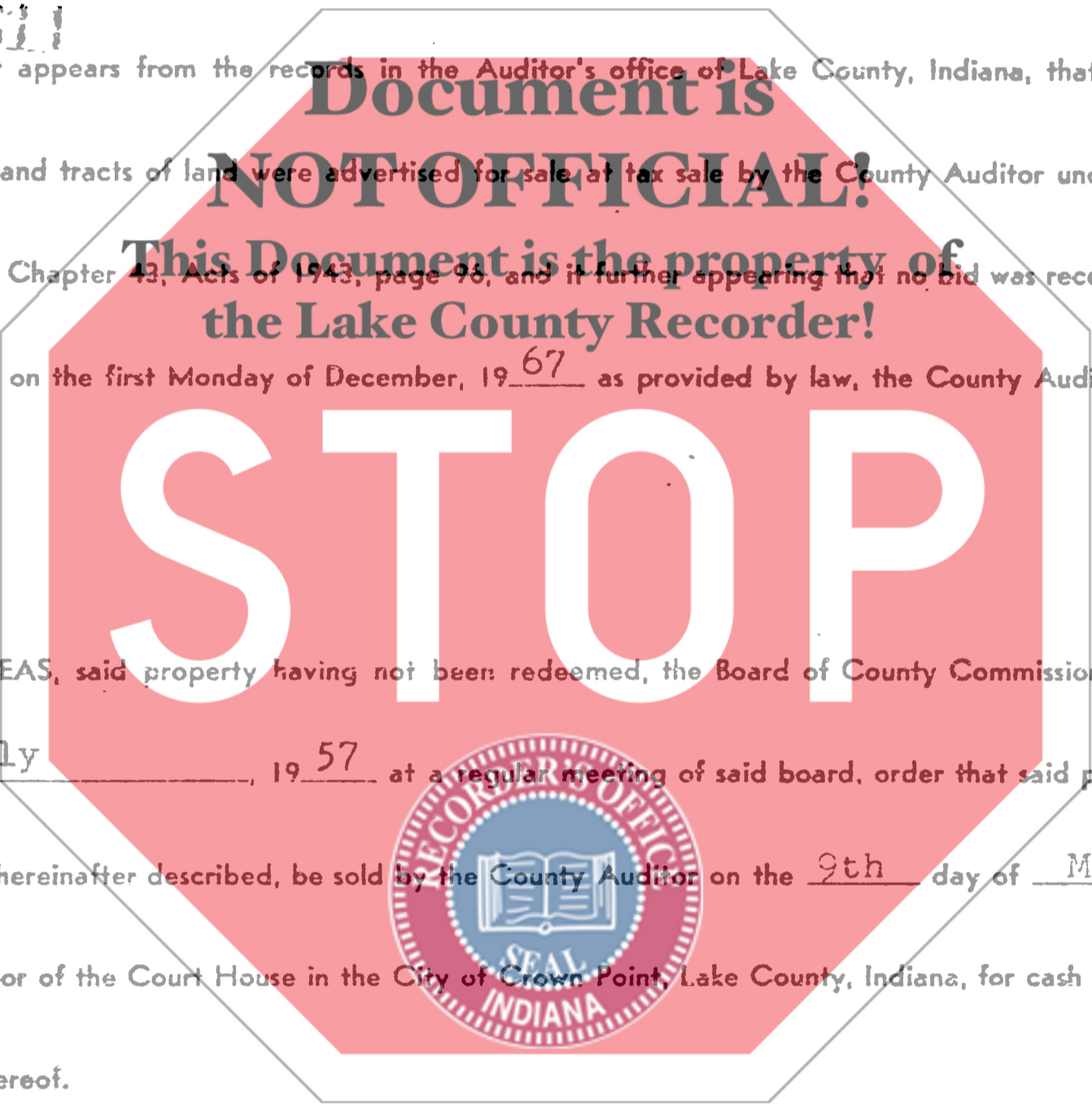

AND, WHEREAS, it appears that notice of the time, terms and place of sale of said real estate was published and posted as required by law,

AND, WHEREAS, it appears that on the day named in the order of the Board of Commissioners, and in the notice as published and posted, the said County Auditor did offer said real estate for sale.

AND, WHEREAS, Jack & Judy Burandt did then and there bid the sum of Fifty Two dollars and five cents, and that the County Auditor did then and there accept said bid.

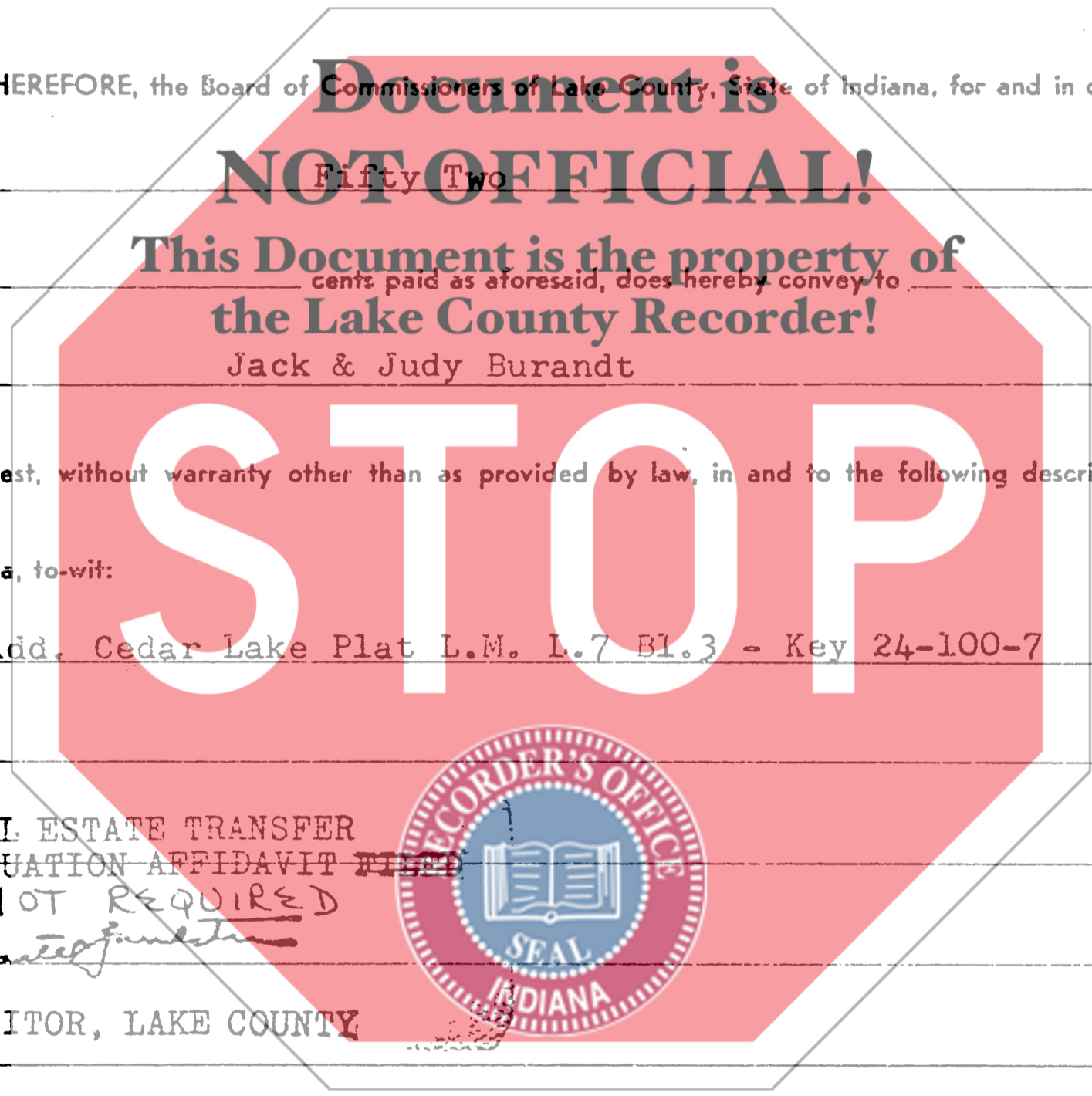
AND, WHEREAS, it appears that Jack & Judy Burandt did thereupon pay the amount of his bid to the County Treasurer of said county in cash.
