ORDER OF ASSENT TO NOTE AND MORTGAGE
BY AN INFANT SPOUSE

Ralph Thomas Puett and Tamara Jo Puett, husband and wife, file their verified petition for assent of the Judge of the Porter Superior Court to the execution of a note and mortgage upon real estate securing such note by reason of the minority of the petitioner, Tamara Jo Puett, which petition reads as follows: (H.I.)

AND NOW, the undersigned Judge of the Porter Superior Court, Porter County, Indiana, having examined said petition, proposed note and mortgage, and being duly advised in the premises now FINDS that said petition is true, that it would be for the benefit of the petitioning minor, Tamara Jo Puett, to execute said note and mortgage, that it will be prejudicial to the petitioning spouse of said minor to be prevented from the execution of the note and mortgage, described in their petition, that said petition should be granted and does hereby assent to the petitioners execution of a note dated at Portage, Indiana, on the 5th day of May, 1970, for the principal sum of \$15,050.00, payable at the office of National Homes Acceptance Corporation in Lafayette, Indiana, with interest at Eight per cent (8%) per annum, in monthly installments of \$110.47, final payment of entire indebtedness evidenced thereby, if not sooner paid, due and payable on the First day of June, 2000, and their execution of a mortgage dated the 5th day of May, 1970, upon the following described real estate:

The South 5 feet of Lot 12, all of Lot 13 and the North 5 feet of Lot 14, in Block "F" in Gary Beach 2nd Subdivision in the City of Gary, as per plat thereof, recorded in Plat Book 21 page 58, in the Office of the Recorder of Lake County, Indiana;

securing the payment of said note, same being the note, mortgage and real estate described in said petition; and does now make and sign the following endorsements of assent upon said note and mortgage, respectively:

"Pursuant to order in Cause No. 70-PSC-784 the execution of this note by Ralph Thomas Puett and Tamara Jo Puett, husband and wife, is assented to this 7th day of May, 1970."

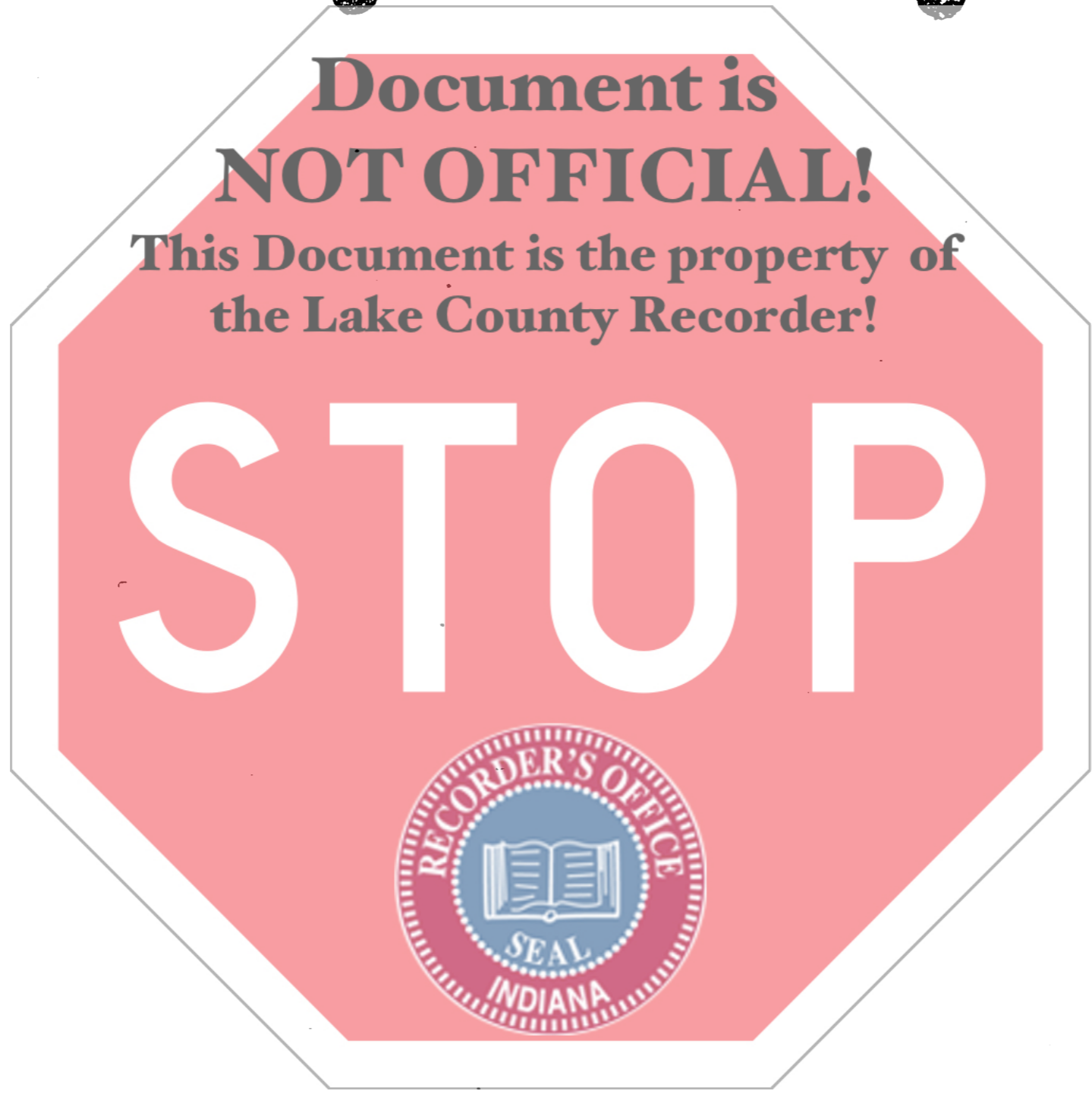

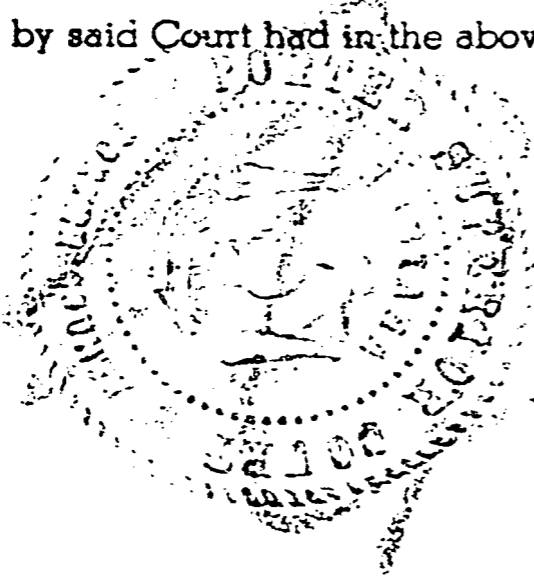
