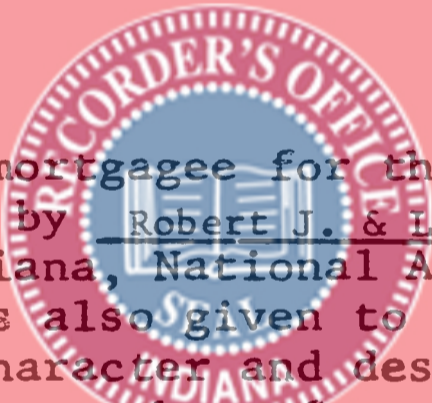
THIS INDENTURE WITNESSETH, That Robert J. & Ligija Gutowsky
