INDEMNIFYING MORTGAGE

THIS INDENTURE WITNESSETH, THAT Jack D. Fisher and Lola E. Fisher, husband and wife of Lake County, in the State of Indiana, hereby mortgage and warrant to The Commercial Bank, Crown Point, Indiana, Lake County, Indiana, the following described property in the County of Lake and State of Indiana

The North 100 feet of the part of the Southeast $\frac{1}{4}$ of Section 5, Township 34 North, Range 8 West of the 2nd Principal Meridian, described as follows: Beginning at the point of intersection of the East line of West Street as now located and the North line of Goldsboro Street as now located; thence East along said North line Goldsboro Street to a point which is 181.35 feet West of the West line of Court Street; thence North and parallel with the West line of Court Street to the North line of said Southeast $\frac{1}{4}$ Southwest $\frac{1}{4}$; thence West along said North line to the East line of West Street as now located; thence South along said East line to the place of beginning, in the City of Crown Point, Lake County, Indiana.

This mortgage is given to the mortgagee for the purpose of securing all indebtedness already owing by Jack D. Fisher and Lola E. Fisher, husband and wife mortgagors to said The Commercial Bank, Crown Point, Indiana, and is also given to secure all indebtedness or liability, of every kind, character and description of the mortgagors, or either of them, to the mortgagee hereafter created, such as future loans, advances overdrafts, and all indebtedness that may accrue to said Bank by reason of the mortgagors or either of them becoming surety or endorser for any other person, whether said indebtedness was originally payable to said Bank or has come to it by assignment or otherwise, and shall be binding upon the mortgagors, and remain in full force and effect until all said indebtedness is paid. This mortgage shall secure the full amount of said indebtedness without regard to the time when same was made. The mortgagors expressly agrees to pay all sums and indebtedness secured hereby, and the same shall be collectable without relief from valuation and appraisal laws and with attorney's fees, and in case it should become necessary to appoint a Receiver for any property that may be secured by this mortgage, it shall not be necessary to serve notice upon the mortgagor.
