To secure the payment of a certain promissory note dated June 20, 1970 in the sum amount of Four thousand three hundred twenty dollars and no cents.

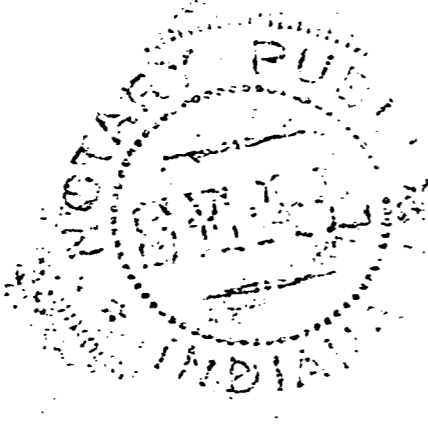
