Comes now the undersigned affiant, and makes this Affidavit in reference to the following described real estate located in Lake County, Indiana, and identified as follows:

Lot One (1), in Block Two (2), in Garden Homes No. 2, as per plat thereof, recorded in Plat Book 25, page 73, in the Office of the Recorder of Lake County, Indiana.

(1) That Edward G. Lockhart is the father of the affiant and that said Edward G. Lockhart died on the 29th day of January, 1966, in Lake County, Indiana;

(2) That on the 29th day of January, 1966, Edward G. Lockhart was married to Pearl Lockhart who is also known and identified as Edna Pearl Lockhart, and that Edna Pearl Lockhart is the mother of the affiant;

(3) That Pearl Lockhart, also known and identified as Edna Pearl Lockhart, died on the 25th day of January, 1968, and on said date, she was a resident of the State of Indiana, County of Lake;

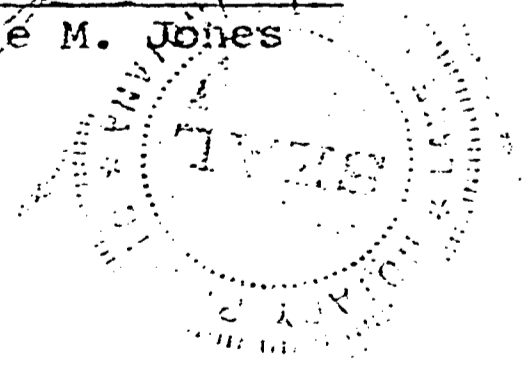
