NOW THE CONDITION OF THIS OBLIGATION IS SUCH,

WHEREAS, the above named and bounden Shirley M. Schmueser has been duly elected and commissioned or appointed Deputy Clerk for Town of Munster in and for Lake County, in the State of Indiana, aforesaid, for the term beginning from the 15th day of February A. D. 1969 and until his successor is duly qualified.
