Part of the East Half (E 1/2) of the Southeast Quarter (SE 1/4) of Section 6, Township 35 North, Range 7 West of the Second Principal Meridian, in the County of Lake, State of Indiana, described as follows:

Beginning at the southeast corner of said Section 6; thence northwardly along the east line of the Southeast Quarter (SE 1/4) of said Section 6 a distance of 328.03 feet to a point; thence westwardly with a deflection angle of 88°-58' to the left a distance of 1317 feet to an iron stake on the west line of the East Half (E 1/2) of the Southeast Quarter (SE 1/4) of said Section 6; thence southwardly with a deflection angle of 91° to the left and along the west line of the East Half (E 1/2) of the Southeast Quarter (SE 1/4) of said Section 6 a

88°-38' to the left and along the south line of
