PARTIAL RELEASE OF RIGHT OF WAY

For the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, Illinois Bell Telephone Company, a Corporation, hereby releases to the owners of record all of its right, title, and interest in the property acquired under a certain right of way easement, dated May 28, 1970 and recorded June 12, 1970 and known as Document Number 61538 in the office of the recorder of Lake County, State of Indiana, being more particularly described as follows:

A parcel of land lying in the Southwest Quarter of Section 10, Township 36 North, Range 9 West of the Second P.M., being more particularly described as beginning at the Northwest corner of the Southwest Quarter of said Section 10, thence South 89 degrees 13 minutes 15 seconds East along the North line of the Southwest Quarter of Section 10 (Said North line also being the center line of 169th Street), a distance of 2039.14 feet to the point of beginning; thence South 0 degrees 46 minutes 45 seconds West, a distance of 233.0 feet; thence South 89 degrees 13 minutes 15 seconds East a distance of 160 feet; thence North 0 degrees 46 minutes 45 seconds East a distance of 233.0 feet to the North line of the Southwest Quarter of said Section 10; thence North 89 degrees 13 minutes 15 seconds West, a distance of 160.0 feet to the point of beginning, excepting the North 33 feet thereof taken for 169th Street, all in the City of Hammond, Lake County, Indiana.
