1. That she is the owner in fee simple of the fol-

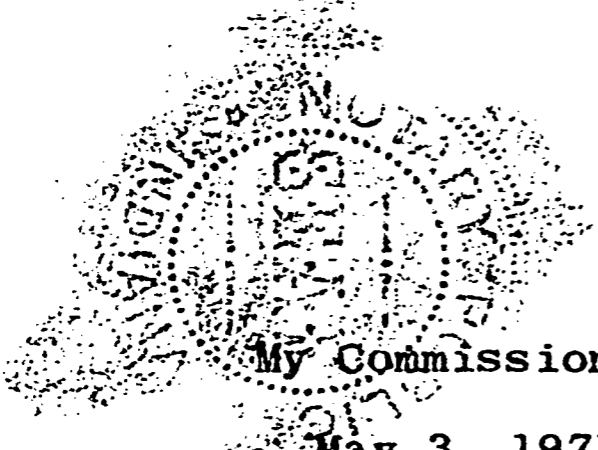
