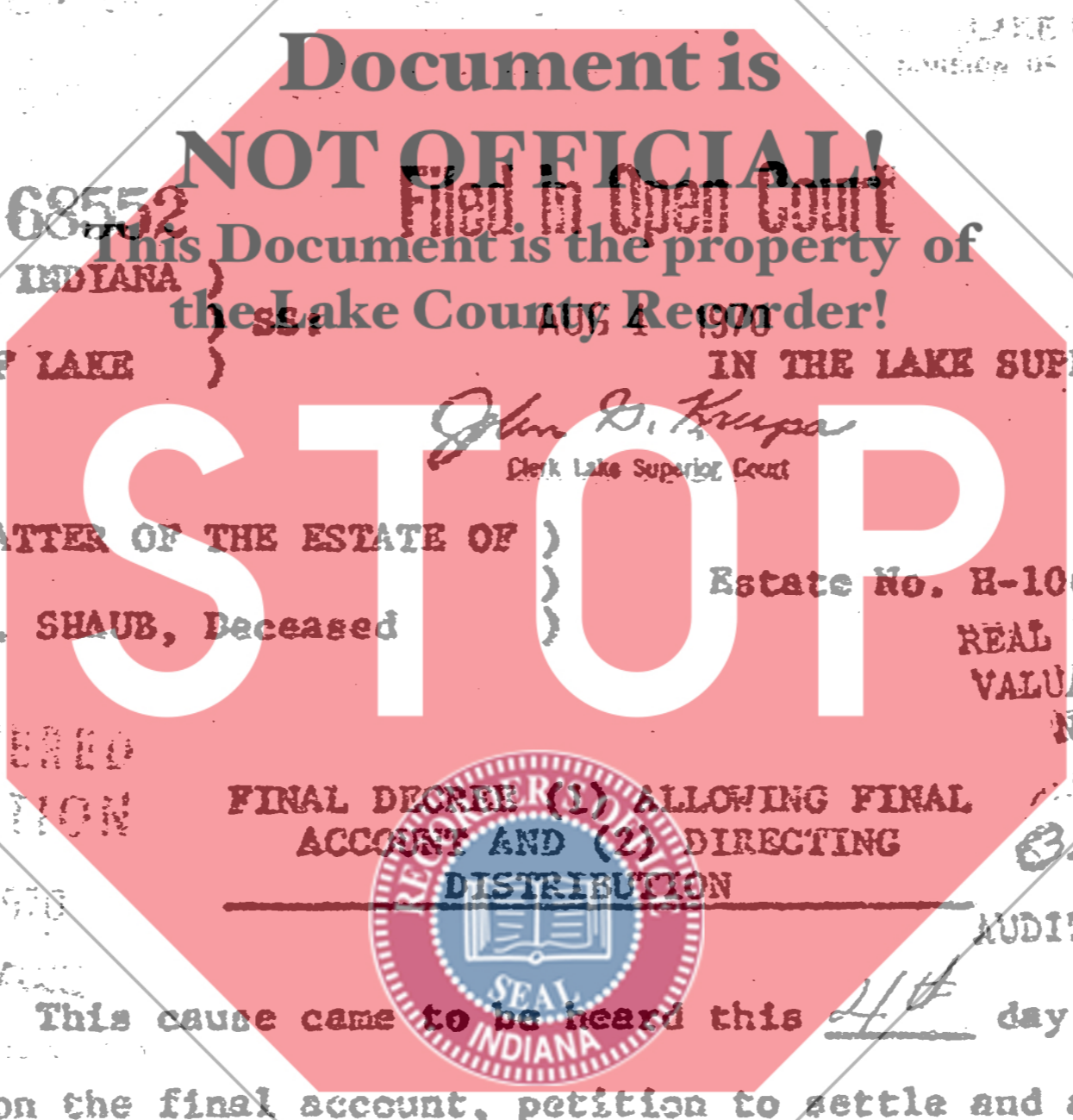

(1) Said report and account of said Administratrix is  
hereby in all things approved, settled and confirmed.

(2) Said Rose Shaub is the spouse and heir at law of the

distribution.
