THIS RELEASE dated this 11th day of June, 1970, by and between LAKE COUNTY TRUST COMPANY, not personally but as Trustee under Trust No. 1411 (herein called the "Owner") and MID AMERICA DEVELOPMENT CORPORATION (herein called the "Contractor"),

W I T N E S S E T H, that:

WHEREAS, Owner and Contractor have heretofore executed and delivered to and with each other, a standard form of Agreement between Owner and Contractor dated as of June 1, 1968 (herein called the "Agreement"), which Agreement was duly filed for record and recorded in the Office of the Recorder of Lake County, Indiana, on July 9, 1968, in Miscellaneous Records Book 968, page 408, as Document No. 756668; and

WHEREAS, the Agreement contemplated that the Contractor would perform certain work upon property therein described, owned by the Owner; and

WHEREAS, the Owner and Contractor desire to amend the Agreement and to release from the contractual provisions thereof, certain real estate owned by the Owner (herein called the "Released Property"), more particularly described in Exhibit A attached hereto.

NOW THEREFORE, in consideration of the foregoing and the agreements hereinafter contained, and in further consideration of TEN DOLLARS (\$10) in hand paid by each party hereto to the other, the receipt and sufficiency of all of which is hereby acknowledged, the parties hereto hereby agree as follows:

1. Owner and Contractor hereby agree that the Released Property described in Exhibit A hereto shall not comprise any part of the real estate within the purview which is the subject of the Agreement and the Agreement is hereby amended to delete therefrom any further reference to the Released Property.

2. Contractor hereby releases any and all rights and claims which it may or might have under or by virtue of the Agreement in and to the Released Property.






