(2) Any advances made by the Mortgages to Mortgagor, or his successor in title, for any purpose, at any time before the release and cancellation of this mortgage, but at no time shall this mortgage secure advances on account of said original note together with such additional advances, provided that nothing herein contained shall be considered as limiting the amounts that shall be secured hereby when advanced to protect the security or in accordance with covenants contained in the mortgage.

(3) All of the covenants and obligations of Mortgagor to the Mortgagee, as contained in a Supplemental Agreement dated, executed and delivered concurrently berewith, and reference is hereby made to the said note and Supplemental Agreement for the full terms and conditions thereof, and the same are hereby incorporated herein as fully as if written out verbatim herein.

All rights and obligations under this mortgage shall extend to and be binding upon the respective heirs, executors, administrators, successors and assigns of the Mortgager and Mortgager.

(4) Said mortgaged premises shall not be sold or transferred without the written consent of the Mortgager, and no contract or agreement shall be entered into by the Mortgagers whereby any one may acquire the right to a lich, mortgage or other incumbrance upon the mortgaged premises, without the written consent of the Mortgagee first had and obtained.
