4. That Milka Srednoselac died a resident of Lake County,
Indiana on May 24, 1966.

5. That Milka Srednoselac died testate and a copy of her
will is attached hereto and made a part of this affidavit and marked
Exhibit "A".

6. That Milka Srednoselac had no property other than her
interest in the above real estate and therefore no estate was opened.

7. That by reason of the death of Milka Srednoselac on May 24,
1966, Ann Zakula became the sole owner in fee of the above described
real estate.

8. That the estate of Milka Srednoselac was not taxable
for federal or state tax purposes because the gross value of the
estate, taking into consideration in the evaluation thereof, the value
of all gifts in contemplation of death, including all gifts made
in the three years next preceding the death, together with the value of
all investments in joint properties and estate by the interests
