

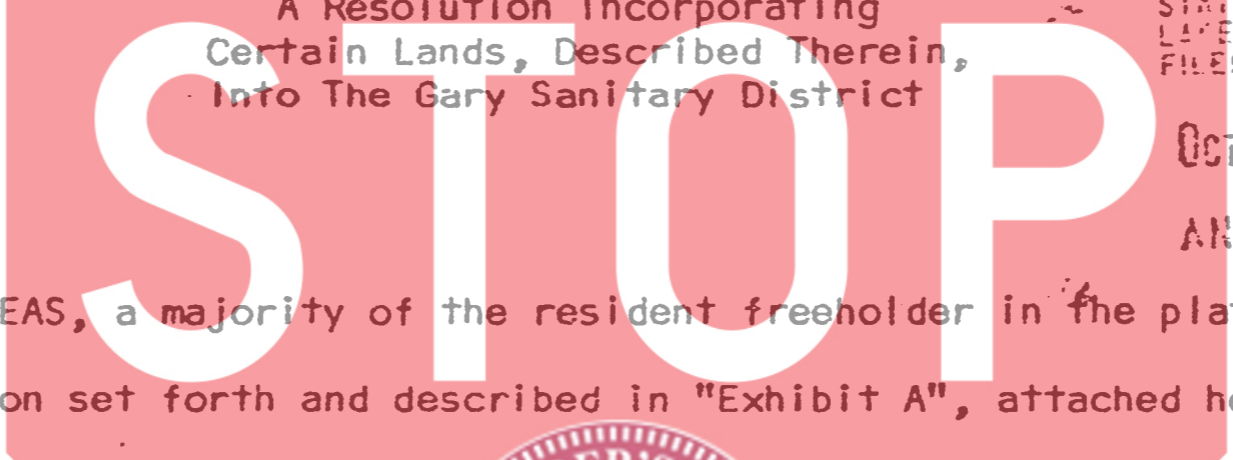

A Resolution Incorporating Certain Lands, Described Therein, Into The Gary Sanitary District

WHEREAS, a majority of the resident freeholder in the platted subdivision set forth and described in "Exhibit A", attached hereto and made a part hereof by reference, and the owners of unplatted land set forth and described in "Exhibit B", attached hereto and made a part hereof by reference, all of which land is within Lake County, Indiana, have applied and requested in writing to be annexed to and to become incorporated into the Gary Sanitary District, and,

WHEREAS, such requests and applications are signed and certified as correct by such resident freeholders and landowners;

NOW, THEREFORE, BE IT RESOLVED by the Board of Sanitary Commissioners of the Sanitary District of the City of Gary, Lake County, Indiana, that the land described in "Exhibit A" and "Exhibit B" herein be, and such now is incorporated in and annexed to the Gary Sanitary District, and,

BE IT FURTHER RESOLVED, that the Secretary of said Board of Sanitary Commissioners of the Sanitary District of the City of Gary shall certify a copy of this Resolution, and append thereto a map showing the boundaries of such Gary Sanitary District, and the location of such additional areas incorporated therein by this Resolution and deliver same to the Auditor of Lake County, Indiana to be indexed and placed on the tax rolls of the Gary Sanitary District and kept in the permanent records of such Auditor.

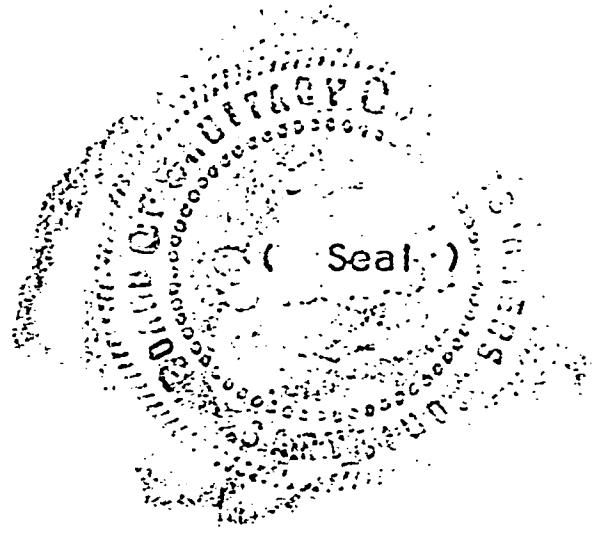

Herron:

Part of the E. 1/2 of the NE 1/4 of the NW 1/4, Section 4, Township 35 N., Range 8 W., of the Second Principal Meridian, and more particularly described as: Beginning at a point on the E. line of said NW 1/4 1054.73' S. of the NE corner of the said NW 1/4, thence 661.72' W., thence S. 131.65', thence E. 661.79' to the East line of said NW 1/4, thence N. 131.65' to the place of beginning, containing 2 acres, except therefrom that part platted as Herron & Owen First Addition.

Part of the E. 1/2 of the NE 1/4 of the NW 1/4, Section 4, Township 35N., Range 8 W., of the Second Principal Meridian, and more particularly described as: Beginning at a point 1186.38' S. of the NE corner of the NW 1/4 aforesaid, thence W. 657.69', thence S. 131.68', thence E. to the East line of the NW 1/4 aforesaid, thence N. to the place of beginning, excepting therefrom that part platted as Herron & Owen First Addition, Plat Book 32, page 62, and also excepting therefrom that part described as: Beginning at the NE corner of Lot 10, Herron & Owen First Addition, thence S. along the E. line, Lot 10 to a point 24' N. of the SE corner thereof, thence E. parallel to S. line of 54th Place 30', thence N. parallel to E. line of said Lot 10, to a point on S. line 54th Place, thence W. along S. line 54th Place 30' to a point of beginning.
