The East half of the Southeast Quarter of Section 35, Township 36 North, Range 8 West of the 2nd Principal Meridian, excepting therefrom the east 155 feet of the north 175 feet thereof, and also excepting therefrom a strip of land sold to Charles Boldt for a road described as follows: Commencing at the northwest corner of the Southeast Quarter of the Southeast Quarter of said Section and running thence south 15 rods to the Hobart Road, thence east 20 feet, thence north 15 rods to the north line of said Southeast Quarter of the Southeast Quarter, thence west 20 feet to the point of beginning, and also excepting therefrom the 100-foot right of way of the Elgin, Joliet and Eastern Railway over and across said land, all in the City of Hobart, Lake County, Indiana.
