Part of the West one-half of Section 9, T 36 N, R 7 W of the Second P.M., in the City of East Gary, Lake County, Indiana, and being more particularly described as follows:

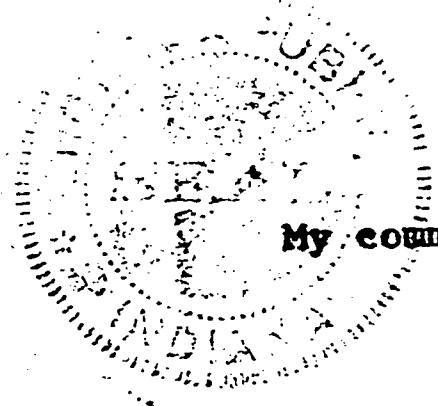
