KNOW ALL MEN, That

JERE DEVELOPMENT COMPANY

herein called the "grantor," in consideration of the sum of one dollar (\$1.00) and other valuable considerations, in hand paid to the grantor, hereby grant to Northern Indiana Public Service Company, an Indiana Corporation, and to its successors and assigns, an easement, right and authority, from time to time, to construct, erect, maintain, operate, repair, replace, renew and remove towers and poles, and to string, install, construct, erect, maintain, operate, repair, replace, renew and remove wires, cables, conductors, guy wires and other necessary equipment upon and between such towers and poles, together ment or use thereof, for the purposes herein described, including the right of ingress and egress to and from the strip of easement land, over adjoining lands of granior and the right to that of control by the rbicides, or at Grantee's option, to cut down and remove from the premises hereinafter described and from the adjoining lands of Grantor any overhanging branches or undergrowth, or any trees of such height which may, in the sole judgement of Grantee, endanger the safety of, or interfere with the use or enjoyment of, any of Grantee's facilities, and to operate by means thereof one or more line or lines for the transmission, distribution and delivery of electrical energy to the public in general, to be used for light, heat, power, telephone and other purposes, in, upon, along and over a strip of land or right-of-way __ Township 34 situated in Section 17 North, Range 8 West of the Second Principal Meridian, in the State of Indiana, described as follows: Lake

The Southerly three feet of Lot #54, as marked and laid down on the recorded plat of Jeffrey Manor Subdivision, Unit #3, as recorded in Book 39, Page 57, in the Office of the Recorder of Lake County, Indiana.

The Southerly three feet of Lot #78, as marked and laid down on the recorded plat of Jeffrey Manor Subdivision, Unit #3, as recorded in Book 39, Page 57, in the Office of the Recorder of Lake County, Indiana.

The Southerly three feet of Lot #98, as marked and laid down on the recorded plat of Jeffrey Manor Subdivision, Unit #3, as recorded in Book 39, Page 57, in the Office of the Recorder of Lake County, Indiana.

The Northerly three feet of lot #77, as marked and laid down on the recorded plat of Jeffrey Manor Subdivision, Unit #3, as recorded in Book 39, Page 57, in the Office of the Recorder of Lake County, Indiana.

Any damages to the crops, tile, fences, or buildings of the grantor on said right-of-way, or on lands of the grantor adjoining the said right-of-way, done by the grantee in the construction, erection, installation, repair, replacement or renewal of said towers, poles, wires, cables, conductors, guy wires, or equipment, shall be promptly paid by the grantee. Patrolling said line or lines shall not constitute grounds for a claim for crop damage.

The grantor reserves the use of the above described land not inconsistent with this grant, but no buildings shall be placed on the right-of-way by grantor.

The grantee shall and will indemnify and save the grantor harmless from and against any and all damage, injuries, losses, claims, demands or costs proximately caused by the fault, culpability, or negligence of the grantee in the construction, erection, maintenance, operation, repair or renewal of said line or lines and the structures and appurtenances connected therewith.

The undersigned grantor hereby covenants to be the owner in fee simple of said real estate, lawfully seized thereof, with good right to grant and convey said easement herein, and guarantees the quiet possession thereof, that the said real estate is free from all encumbrances, and that the grantor will warrant and defend the title to the said easement against all lawful claims.

These presents to be binding on the heirs, executors, administrators, grantees and assigns of the grantor, and upon the grantee, its successors and assigns.
