Together with all and singular, the tenements and appurtenances thereto belonging or in anywise appertaining, to secure the payment when the same shall become due, of the certain principal note of said mortgagor, bearing even date herewith, made to said payable at the banking room of the American Trust and Savings Bank of Whiting, Indiana, with interest thereon at the rate of 7 3/4 % per annum, payable monthly, and at the maturity of the principal note, said principal note being for the following amount and due and payable as follows:

One Principal note for Twenty-eight Thousand and no/100 Dollars---- (\$28,000.00) payable as follows: Two hundred sixty-three and 57/100 (\$263.57) on the 10th day of each and every month beginning on the 10th day of December 1970 for 179 months succeeding, and a final payment of Two hundred sixty-three and 57/100 (\$263.57) on the 10th day of November, 1985. (Payment of \$263.57 monthly includes principal and interest.)

and this mertgage is given for the equal security and benefit of the holder or holders of any of said note described berein.

For the purpose of inducing the said mortgage to make the loan hereby secured, the mortgager g expressly represent and warrant to said mortgage that they are , the owner g in fee simple of the said premises herein mortgaged; that the title is clear and free from all incumbrances of whatever kind and nature, and that this mortgage is all and the only incumbrance on said premises, and that the said mortgagor S further represent that they are of the full age of twenty-one years, and the mortgagor g expressly agree to pay the sums of money above secured and attorney's fees, without relief from valuation and appraisement laws, and upon failure to pay any one of said note or any part thereof at maturity, or the interest thereon, or any part thereof when due, or the taxes or insurance as hereinafter stipulated, then all of said note—shall be due and collectible at mortgagee's option and notice of the exercise of said option is hereby expressly waived and said indebtedness shall be recoverable by a suit at law, or a foreclosure hereof, or both, to the same extent as if the same had matured by express terms.
